Message from the Superintendent

Dear Remsen Community,

Genuinely good, hard-working people make Remsen a very special place to live, learn, and work. Collectively, we understand that our goal must always be to ensure that we leave our children, for generations to come, with an even better community and school than we had. This is accomplished by continuing to work together to help cultivate our Remsen community and by providing our children the ability to receive an innovative education, full of diverse learning opportunities and experiences. The level of support that our students receive from every district resident is appreciated beyond words. Even if you currently do not have students enrolled in school, your support of Remsen Central plays a critical role in raising, teaching, and growing our youth into productive, responsible, kind, hard-working citizens. It truly does make a difference.

We have been hard at work preparing our *Student Opportunities Plan* (proposed budget) for the 2023-2024 school year. Thoughtful planning and monthly work sessions enabled our team to develop a fiscally responsible budget, responsive to our students' needs, with only a slight tax levy increase of 1%. This increase is well below our allowable New York State Property Tax Cap levy increase limit and reflects our commitment to balance the needs of our school district with the challenges that we, as a society, continue to live in.

In addition to voting on the proposed 2023-2024 budget in the amount of \$14,315,125, we will also be voting on two propositions. The first proposition on the ballot will be for the purchase of one 66-passenger school bus. The proposed purchase is part of an ongoing bus replacement plan designed to keep the District's fleet in safe, working order by phasing out buses that are no longer cost effective to maintain. If the proposition is approved, the actual cost to the District will be significantly less than the amount sought. Approximately 82.6% of the cost would be reimbursable through state aid.

The second proposition on the ballot will be to create a capital reserve account to fund improvements to our buildings, fields, and parking lots. This savings account will have a limit of \$2,500,000 and is where we may deposit surplus funds over time. Saving for large future capital project expenses is a very important part of maintaining a stable financial condition while ensuring our facilities are safe, efficient, and remain a source of community pride.

Our budget hearing will take place on Tuesday, May 9th at 6:00 PM in the elementary library media center. Please consider joining us to learn more about our *Student Opportunities Plan* and to hear from our one Board of Education candidate seeking election. If you are unable to attend, the full presentation will be posted to our webpage shortly thereafter. Additional budget and Board of Education election information may also be found throughout this newsletter. Please do not hesitate to reach out if you have any questions.

Our school budget vote will take place on Tuesday, May 16th, from 1:00 PM until 8:00 PM in the Elementary cafeteria. Voter parking spaces will be reserved at the front of the elementary parking lot closest to the cafeteria doors. Back by popular demand, our FFA students will be selling plants outside of the cafeteria doors starting at 3:00 PM and student artwork will be on display for all to enjoy.

Outstanding educational programs, beautiful facilities and exciting extracurricular clubs and teams; Remsen School District's strong community makes it all possible for our students. *We are Remsen!* As always, your *support* of, and *pride* in, Remsen Central School will ensure that our students continue to *Soar to Success.* Thank

Capital

Funds are also included here for the lease and purchase of buses, payment of debt for capital projects (principal and interest), refund of taxes and insurance. The final piece of this budget is a transfer to capital for ongoing building improvements.

Who Can Vote?

To be eligible to vote, a resident must have lived in the Remsen Central School District for at least 30 days prior to the May 16 election, be at least 18 years of age, a citizen of the United States and registered to vote with the school district. No person shall have the right to register for or vote who would not be qualified to register for or vote at an election in accordance with the provisions of section 5-106 of the Election Law.

Can I Vote by Absentee Ballot?

Residents who will not be in the area on May 16, or who are unable to vote in person may apply for an absentee ballot at the Remsen Central School District Office. If the absentee ballot is to be mailed to the voter, the application must be submitted at least seven days prior to the vote. If the absentee ballot is to be picked up by the voter in person, applications will be accepted until May 15. Absentee ballots must be returned to the district clerk no later than 5:00 PM on May 16.

Propositions on the Ballot

2023-2024 BUDGET PROPOSITION

RESOLVED, that the 2023-2024 Budget for the Remsen Central School District, in the amount of \$14,315,125 is hereby adopted and the requisite portion thereof is to be raised by taxation on the taxable property of the District.

Proposition #1 - Bus Purchase


RESOLVED, that the Board of Education of the Remsen Central School District is hereby authorized to undertake the acquisition of one 66-passenger school bus, not to exceed estimated maximum cost of \$151,888, less trade-in value, if any, and that such costs, or so much thereof as may be necessary,

shall be raised by the levy of a tax to be collected in annual installments; and in anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$151,888 shall be issued, or the school district may enter into an installment purchase contract if the Board of Education determines that it is in the best interest of the school district to finance the purchase in that method.



A second separate proposition is to create a reserve account to fund improvements to our buildings, fields, and parking lots. This savings account will have a limit of \$2,500,000 and is where we will deposit surplus funds over time. Saving for large future capital project expenses is a very important part of maintaining a stable financial condition while ensuring our facilities are safe, efficient, and remain a source of community pride.

RESOLVED, that the Board of Education of the Remsen Central School District is hereby authorized to establish a capital reserve fund pursuant to Section 3651 of the Education Law to be designated, "2023 Capital Reserve Fund" created to defray the cost of the construction, reconstruction and equipping of School District buildings and facilities, including original equipment, machinery, apparatus, appurtenances, furnishings, land acquisitions, and other incidental improvements and expenses in connection therewith, and to defray the cost of, in whole or in part, and in order to accomplish the same, the Board is hereby authorized to establish the ultimate amount of such reserve fund to Two Million Five Hundred Thousand Dollars (\$2,500,000) inclusive of accrued interest and other investment earnings, with a probable term of ten (10) years. The Board of Education is hereby authorized to pay funds from the available fund balance, state aid reimbursement to the School District on account of capital projects, such other monies as the voters may direct, and/or other legally available funds of the School District to such reserve fund in an amount determined by the Board of Education up to the maximum authorized amount.

CAPITAL OUTLAY PROJECT UPDATE

District-wide Safety and Security Enhancements

NO ADDITIONAL FINANCIAL IMPACT OT THE COMMUNITY

Anticipated Start: 2023-2024 School Year

The proposed 2023-2024 Remsen Central School District budget includes a \$100,000 Capital Outlay Project. It is important to note that the Remsen Central School District will be reimbursed by the state for 83.5% of the Capital Outlay Project's cost. In other words, a \$100,000 project only costs the district \$16,500.

The proposed project for next year will be to enhance the overall safety and security district-wide. Specifically, the scope includes installation of a blue light strobe system and push buttons for emergency lock downs, an Automatic 911 Dialer Incident Response Panel that immediately contacts 911 as soon as one of our buildings goes into a lock down, and remaining perimeter door contacts to alert staff when a door is ajar.

One of our overarching goals for the Remsen Central School District is to continue to provide safe, efficient and operational facilities for our students and our community members. Capital Outlay Projects allow us to responsibly make necessary improvements without placing a large burden on the community.


POSITIVITY PROJECT

On March 16, Remsen Elementary students engaged in a Positivity Project (P2) ceremony for making it more than halfway through the program.

Students in grades pre-K through sixth grade gathered in the cafeteria and listened as Principal Winghart and the sixth grade presenters discussed the themes of P2. Each presenter discussed an attribute that they learned about through the program and discussed examples of how to apply the lessons to their own lives.

After each sixth grader presented, they announced the names of students in the elementary school who demonstrated the attributes discussed: teamwork, integrity, gratitude, kindness, self-control and perseverance. Each student called upon was awarded a personalized certificate by Principal Winghart and Ms. Kistowski, recognizing their hard work.

P2 is a 32-week program for schools, with more than 160 daily lessons that are differentiated for grades pre-K-12. The P2 program runs for a portion of the school year through daily 15-minute lessons, and focuses on a common schoolwide vocabulary developed through consistency and naturally woven throughout the entire school day.

Each year, the New York State Bar Association presents a case for students to bring to life. Students then work to prepare their cases by learning designated roles and preparing questions specific to the case that will then be heard before a judge. Schools alternate between the prosecution and the defense and compete on the basis of their opening statements, witness direct examination and cross examination, witness preparation, professionalism and closing statements. Each component of the trial is timed, so students must be able to quickly adapt their line of questioning based on the witnesses' answers and the opposing counsel's direct examination questions. The entire mock trial process helps students to develop skills including public speaking, communication, problem solving, teamwork and critical analysis while working within strict legal guidelines.
