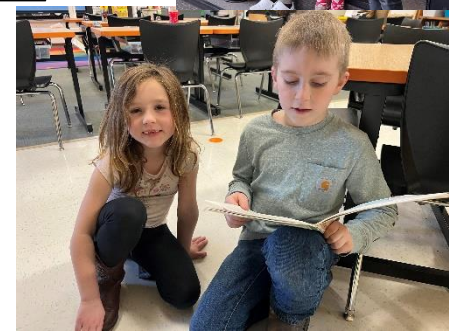
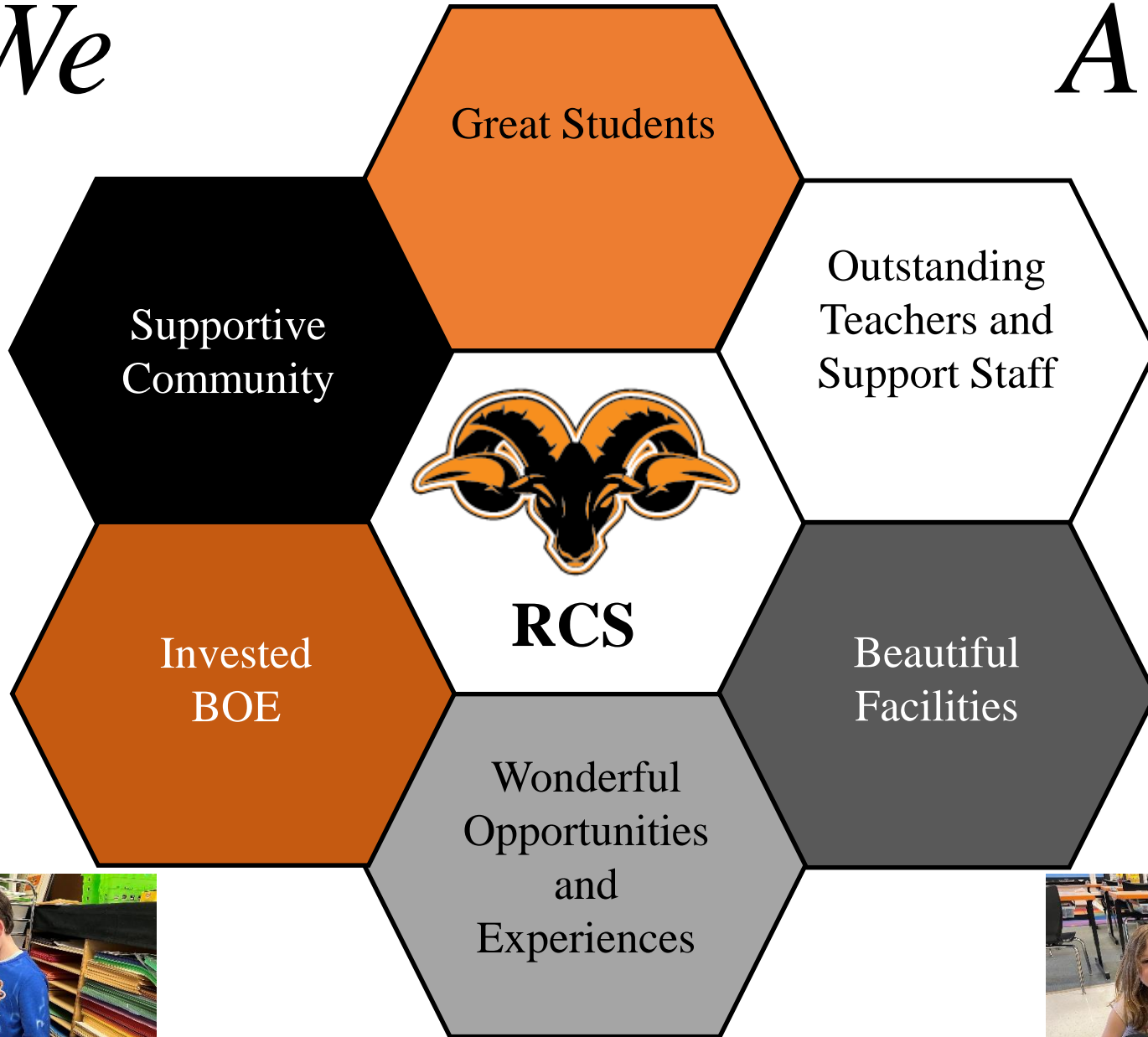

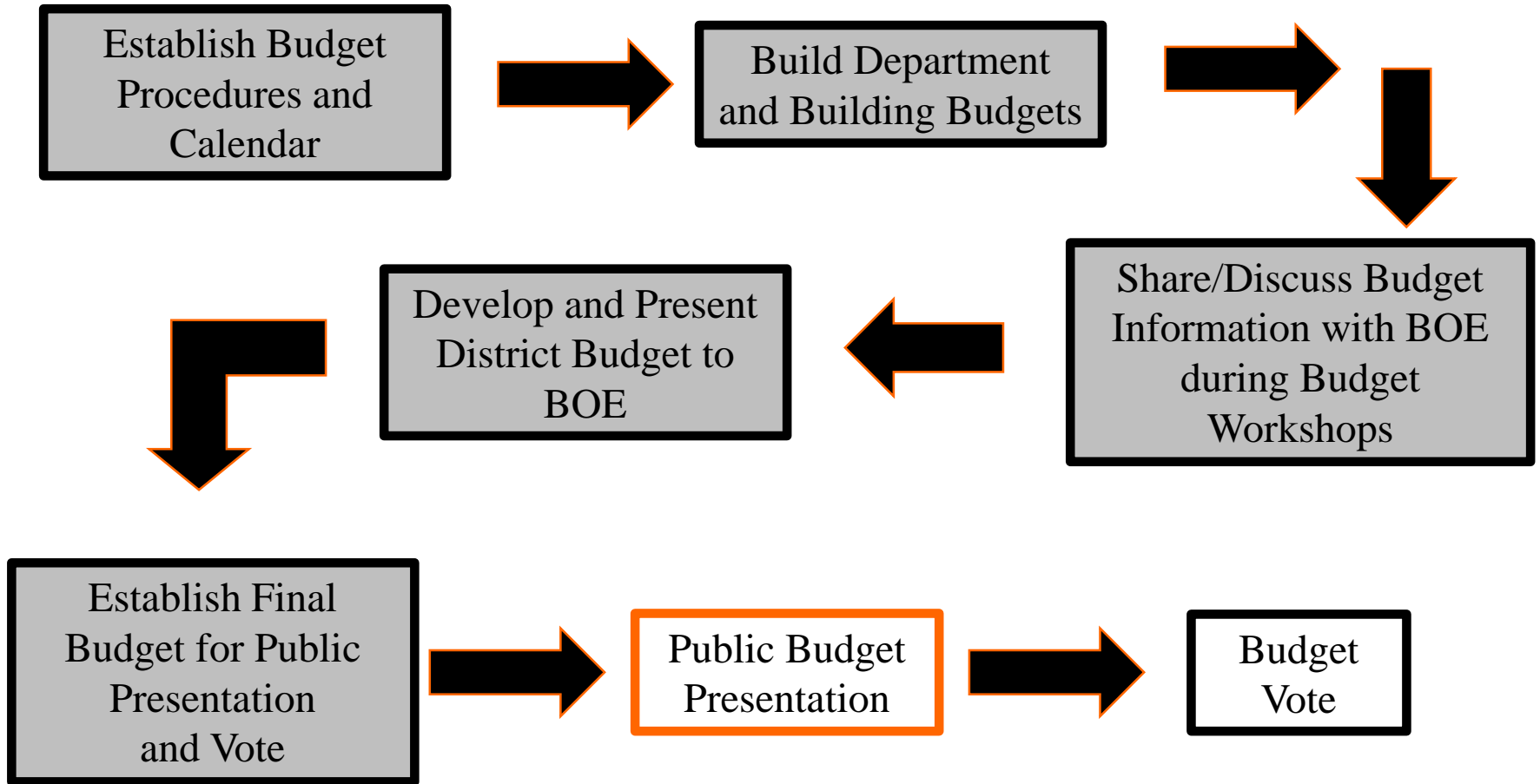

## Capital

The capital budget includes costs associated with operations and maintenance of buildings, upkeep of grounds, electricity, heat, oil, water, sewer and telephone services. Funds are also included here for the lease and purchase of buses, payment of debt for capital projects (principal and interest), refund of taxes, and insurance. The final piece of this budget is a transfer to capital for ongoing building improvements.

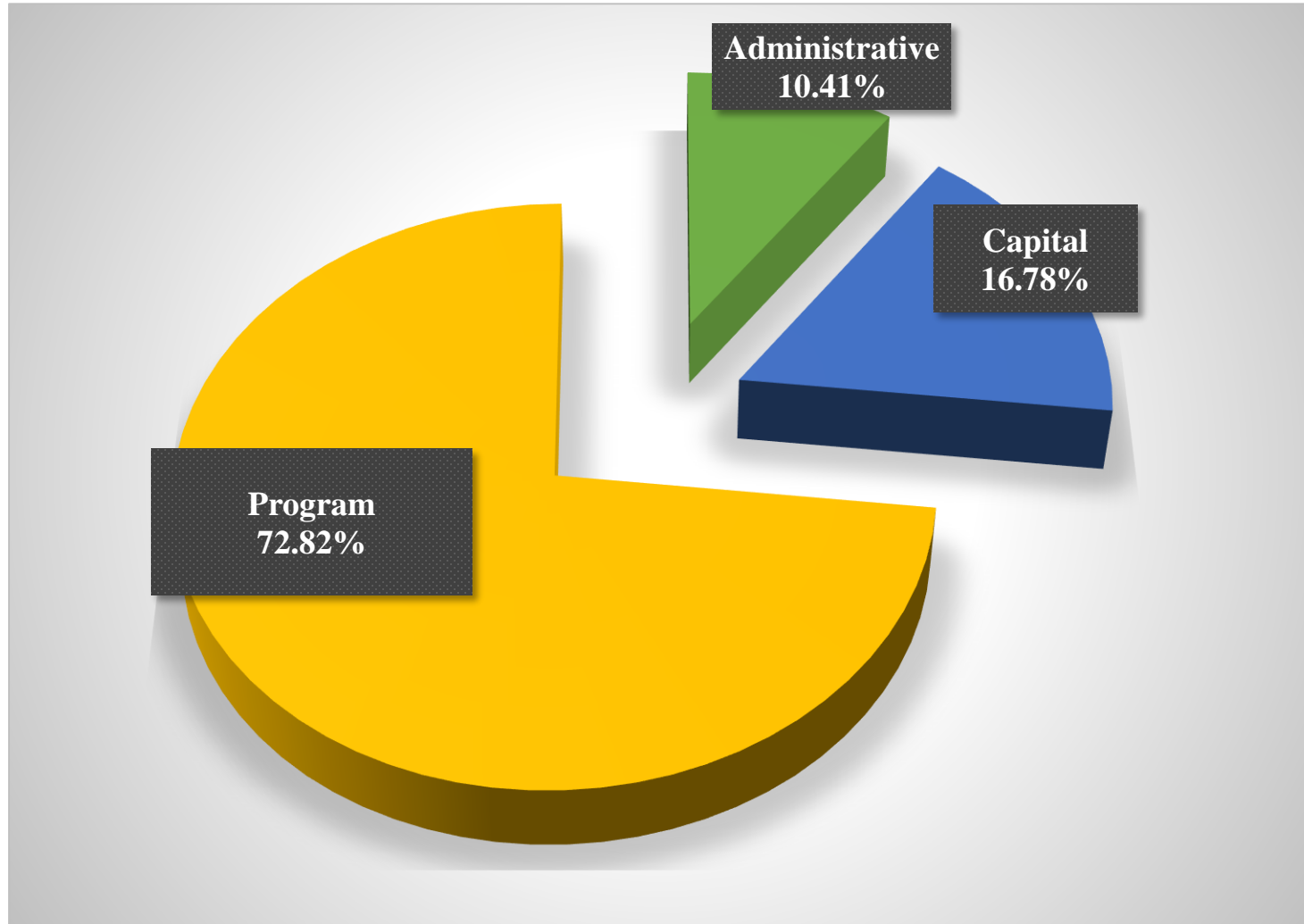

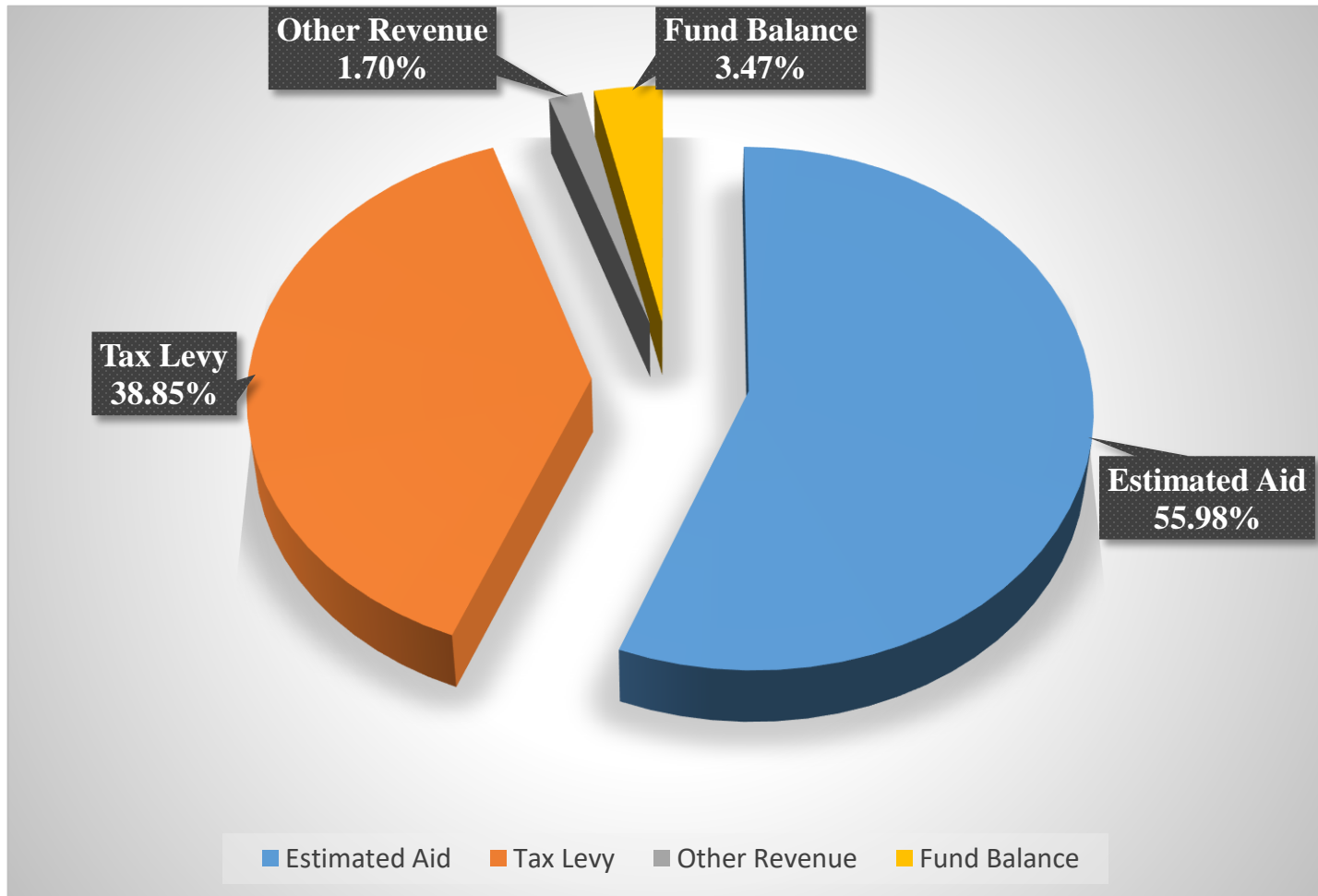

## Why a small tax levy increase?

*Even with a small increase in the tax levy (1.00%), the estimated gap between revenue and expenditures is still \$509,143.*

*A 1.00 % increase in Remsen's tax levy equates to \$56,458.*

*Operational costs, health insurance, and retirement contributions continue to increase **while NYS Foundation Aid is frozen for the upcoming school year.***

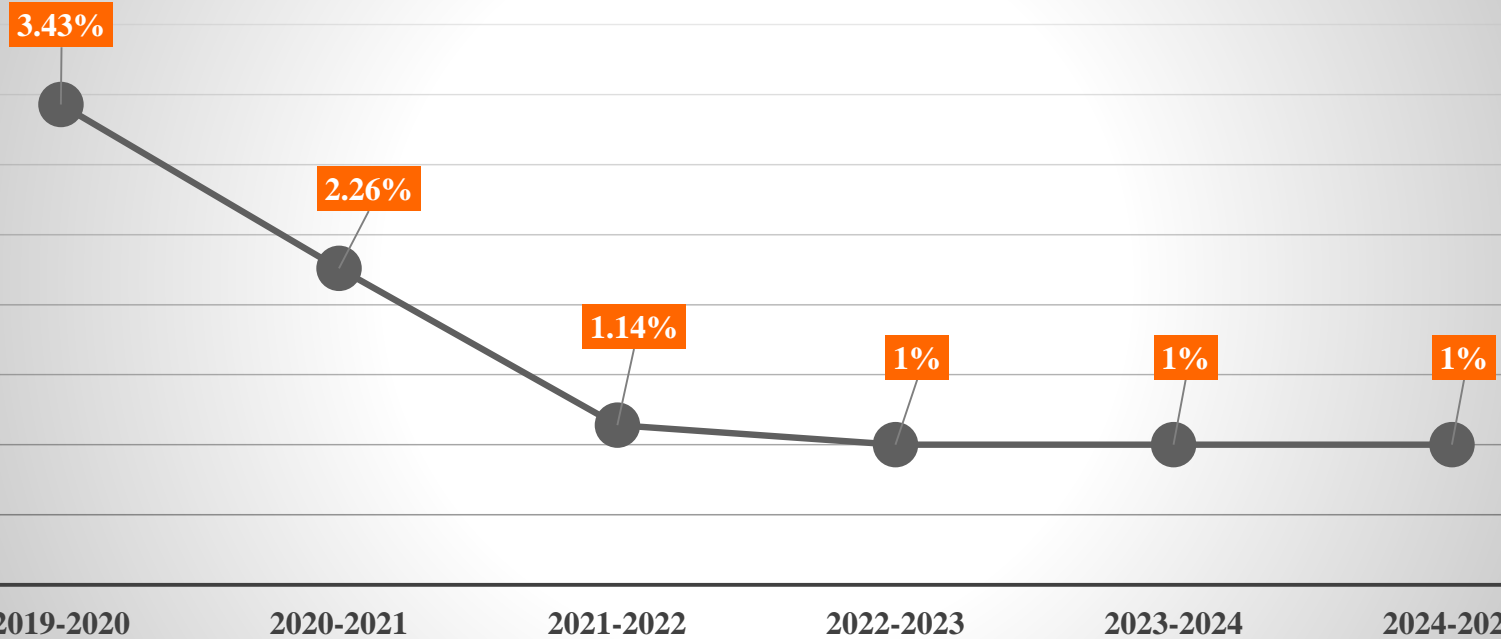

# We Understand and Work to Minimize Our Community Tax Burden

## What did we do to help ensure that our 2024-2025 operating budget only increased slightly for next year?

- 1) Remaining fiscally responsible while working to ensure that all of our students receive a quality educational experience.
- 2) Responsible Use of American Rescue Plan Grant funds over the last several years to ensure that we did not create our own fiscal cliff.
- 3) Integrate the use of fund balance to minimize the tax burden on the community.
- 4) Forward-thinking to maintain a responsible fund balance and build reserves.
- 5) Thoughtful planning as vacancies occur to optimize personnel and contain costs.
- 6) Potential savings realized on new staff hires due to retirements.





Continue to Include \$100,000 Capital Outlay Project  
Each Year (*Building Aid = 83.5%*)

Responsible Facilities and Maintenance Planning

*Actual District Cost After Aid = \$16,500*

No Additional Impact to Tax Payers

Scope for the 2024-2025 Capital Outlay: Jr./Sr. High School Stage Wood Floor, Stairs, and Ramp. Additional high school floor base molding in high need areas will be addressed with any remaining funds.



## School Bus Purchases 2024-2025

One 66-passenger bus and one 20-passenger bus all at an estimated maximum aggregate cost of \$255,000, less trade-in value.

*Estimated District Cost After Aid = \$44,370*

# In the Event of a Budget Defeat

- Option 1: Keep Same Budget and Vote Second Time
- Option 2: Develop a Revised Budget for Voter Approval
- Option 3: Adopt a Contingency Budget



## Contingency Budget Limitations:

1. Tax Levy no greater than in the last successful budget.
2. Removal of equipment.
3. Removal of raises for employees not covered by a collective bargaining agreement.
4. Administrative Component as a % of the sum of Administrative and Program Components no greater than in the last successful budget.
5. No public use of school buildings/grounds unless district charges fee that meets or exceeds actual costs.
6. No non-emergency capital expenditures

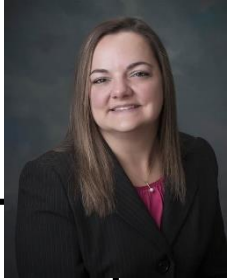

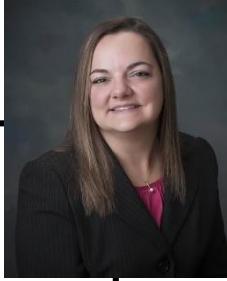

## PROPOSITION 1

### School Buses

RESOLVED, that the Board of Education of the Remsen Central School District is hereby authorized to undertake the acquisition of one (1) 66-passenger school bus at an estimated maximum cost of \$169,100, and one (1) 20-passenger school bus at an estimated maximum cost of \$85,900, all at an estimated maximum aggregate cost of \$255,000, less trade-in value, if any, and that such costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments: and, in anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$255,000 shall be issued, or the school district may enter into an installment purchase contract if the Board of Education determines that it is in the best interest of the school district to finance the purchase in that method.

## PROPOSITION 2

### Didymus Thomas Public Library

RESOLVED, that the Board of Education of the Remsen Central School District is hereby authorized to increase the appropriation for the Didymus Thomas Library to the sum of \$59,500 per year; to levy taxes in the said amount of \$59,500 annually; and to pay over such moneys to the Board of Trustees of the Didymus Thomas Library for the operation of the Didymus Thomas Library.

### A note from the Didymus Thomas Library Board of Trustees

*Dear Remsen Central School District Voter:*

*When you go to the polls on May 21, 2024 to vote on the Remsen Central School budget, you will find a separate proposition seeking support for the Didymus Thomas Library with a levy increase from \$41,500.00 to \$59,900.00. Taxpayer funding of the library has remained unchanged since 2014. If the library is to maintain its current level of services, we need your support. County and State funding to the library is being steadily reduced while our circulation has increased from 8,451 items in 2021 to 9,288 items in 2023. For an individual taxpayer with a \$100,000 home, the projected increase is less than \$13 per year. We hope you will continue to support the library's mission to enhance our quality of life and enable it to remain in service to our community for many years to come.*

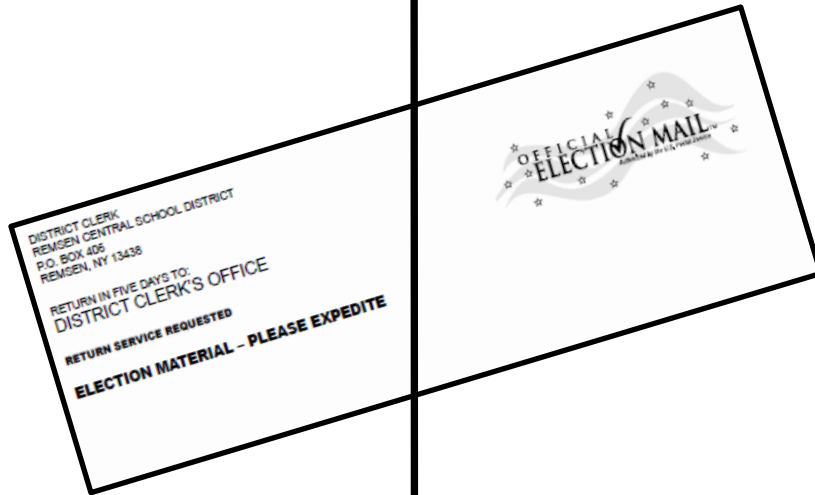

## Can I Vote By Absentee Ballot?

Residents who will not be in the area on May 21, or who are unable to vote in person, may apply for an absentee ballot at the Remsen Central School District Office. 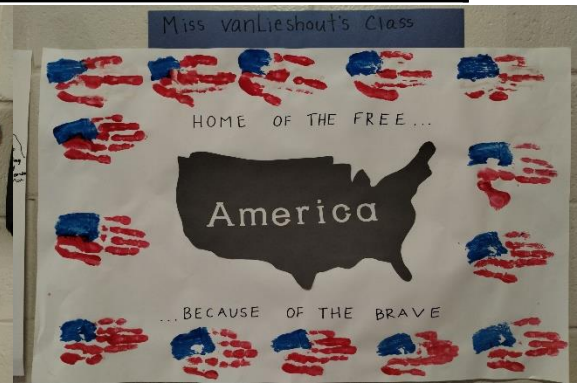
