MESSAGE FROM THE SUPERINTENDENT

Dear Remsen Community,

Remsen is a very special place to live, learn, and work. Together, we understand that our goal must always be to ensure that we leave our children, for generations to come, with an even better community and school than we have today. This is accomplished by continuing to work together to provide our children with a solid academic foundation, full of diverse learning opportunities and experiences. Even if you currently do not have students enrolled in school, your support of Remsen Central plays a critical role in raising, teaching, and growing our youth into productive, responsible, kind, hard-working citizens. Your support truly does make a difference.

We have been hard at work preparing our Student Opportunities Plan (proposed budget) for the 2024-2025 school year. Sadly, our New York State governor has presented school districts across the state with the inexcusable burden of inadequate funding. Many school districts, including Remsen, will now need to operate during the 2024-2025 school year without an increase in Foundation Aid, our main source of State Aid revenue. We anticipated this abhorrent outcome from NYS and prepared our plan for the upcoming school year accordingly. Thoughtful planning and monthly Board of Education work sessions enabled our team to develop a fiscally responsible budget, responsive to our students' needs, with only a slight tax levy increase of 1%. This increase is well below our allowable New York State Property Tax Cap levy increase limit and reflects our continued commitment to balance the needs of our school district with the challenges that we all realize.

In addition to voting on the proposed 2024-2025 budget in the amount of \$14,677,461, we will also be voting on two propositions. The first proposition on the ballot will be for the purchase of one 66-passenger school bus and one 20-passenger school bus. The proposed purchase is part of an ongoing bus replacement plan designed to keep the District's fleet in safe, working order by phasing out buses that are no longer cost effective to maintain. If the proposition is approved, the actual cost to the District will be significantly less than the amount sought. Approximately 82.6% of the cost would be reimbursable through state aid.

The second proposition on the ballot will be to increase the Didymus Thomas Public Library levy. The Didymus Thomas Library plays an integral role in our community for youth and adults alike. A message from the library Board of Trustees may be found in this newsletter.

Our budget hearing will take place on Tuesday, May 14 at 6:00 p.m. in the elementary library media center. Please consider joining us to learn more about our Student Opportunities Plan and to hear from our one Board of Education candidate seeking election. Members of the Didymus Thomas Library Board of Trustees will also be present to answer questions regarding the proposed library levy increase. If you are unable to attend, the full presentation will be posted to our webpage shortly thereafter. Additional budget and Board of Education election information may also be found throughout this newsletter. Please do not hesitate to reach out if you have any questions.

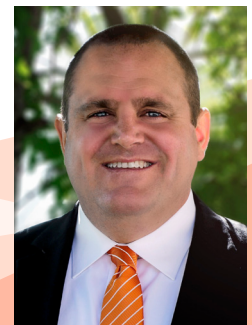

Capital

The capital budget includes costs associated with operations and maintenance of buildings, upkeep of grounds, electricity, heat, oil, water, sewer and telephone services. Funds are also included here for the lease and purchase of buses, payment of debt for capital projects (principal and interest), refund of taxes and insurance. The final piece of this budget is a transfer to capital for ongoing building improvements.

Who Can Vote?

To be eligible to vote, a resident must have lived in the Remsen Central School District for at least 30 days prior to the May 21 election, be at least 18 years of age, a citizen of the United States and registered to vote with the school district. No person shall have the right to register for or vote who would not be qualified to register for or vote at an election in accordance with the provisions of section 5-106 of the Election Law.

Can I Vote by Absentee Ballot?

Residents who will not be in the area on May 21 or who are unable to vote in person may apply for an absentee ballot at the Remsen Central School District Office. If the absentee ballot is to be mailed to the voter, the application must be submitted at least seven days prior to the vote. If the absentee ballot is to be picked up by the voter in person, applications will be accepted until May 20. Absentee ballots must be returned to the district clerk no later than 5:00 p.m. on May 21.

Propositions on the Ballot

2024-2025 BUDGET PROPOSITION

RESOLVED, to adopt the annual budget of the Remsen Central School District in the amount of \$14,677,461 for the fiscal year 2024-2025 and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.

Proposition #1 - Bus Purchase

RESOLVED, that the Board of Education of the Remsen Central School District is hereby authorized to undertake the acquisition of one (1) 66-passenger school bus at an estimated maximum cost of \$169,100, and one (1) 20-passenger school bus at an estimated maximum cost of \$85,900, all at an estimated maximum aggregate cost of \$255,000, less trade-in value, if any, and that such costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments; and, in anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$255,000 shall be issued, or the School District may enter into an installment purchase contract if the Board of Education determines that it is in the best interest of the School District to finance the purchase in that method.

Proposition #2 – Didymus Thomas Library

RESOLVED, that the Board of Education of the Remsen Central School District is hereby authorized to increase the appropriation for the Didymus Thomas Library to the sum of \$59,500 per year, to levy taxes in the said amount of \$59,500 annually, and to pay over such moneys to the Board of Trustees of the Didymus Thomas Library for the operation of the Didymus Thomas Library.

NO ADDITIONAL FINANCIAL IMPACT OT THE COMMUNITY

Anticipated Start: 2024-2025 School Year

The proposed 2024-2025 Remsen Central School District budget includes a \$100,000 Capital Outlay Project. It is important to note that the Remsen Central School District will be reimbursed by the state for 83.5% of the Capital Outlay Project's cost. In other words, a \$100,000 project only costs the district \$16,500.

The proposed project for next year will be to replace the failing tile floor on the Jr./Sr. High School stage with a wood floor specified for a stage. This work will also include replacement of the stage stairs and ramp flooring. Additional high school floor base molding in high need areas will be addressed with any remaining funds.

One of our overarching goals for the Remsen Central School District is to continue to provide safe, efficient and operational facilities for our students and our community members. Capital Outlay Projects allow us to responsibly make necessary improvements without placing a large burden on the community.

A Message from the Elementary School Principal

Dear Remsen Families,

As the end of the school year very quickly approaches, it is always neat to look back to the beginning of the year and to reflect on all of the growth and progress that each student has made over the course of one school year. At this point in the school year, our pre-kindergarten students are looking more like kindergarten students and our sixth graders are all too ready to move on to the Jr./Sr. high school. We have our Elementary Career Day, Olympic Day, our third trimester Evening of Excellence and many other events to look forward to. Also, be on the lookout for more information about our plans for summer programming. We are planning to provide summer camps/programs similar to those that we've offered the last few years.

On May 23, all STEAM Club members are invited to continue the fun in a culminating activity at STEAM Family Fun Night at Remsen Elementary School.



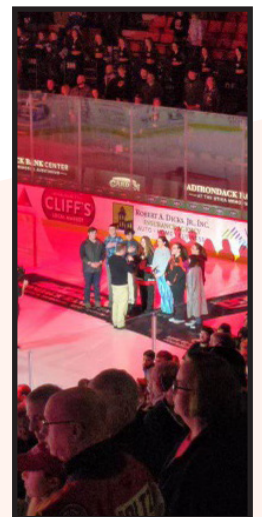
ZACH HELMER NAMED CSC DIVISION III FIELD ATHLETE OF THE MEET FOR INDOOR SEASON

Why do you think it is important to serve the community and school as a BOE member?

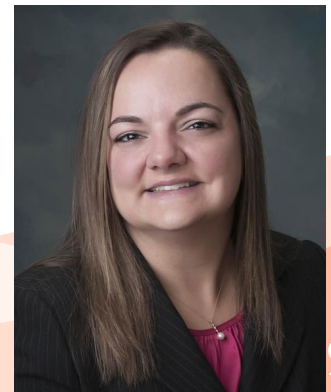

A note from the Didymus Thomas Library Board of Trustees

Dear Remsen Central School District Voter:

When you go to the polls on May 21, 2024 to vote on the Remsen Central School District budget, you will find a separate proposition seeking support for the Didymus Thomas Library with a levy increase from \$41,500 to \$59,900. Taxpayer funding of the library has remained unchanged since 2014. If the library is to maintain its current level of services, we need your support. County and state funding to the library is being steadily reduced while our circulation has increased from 7,268 items in 2014 to 9,288 items in 2023 – an increase of 28%. For an individual taxpayer with a \$100,000 home, the projected increase is less than \$13 per year. We hope you will continue to support the library's mission to enhance our quality of life and enable it to remain in service to our community for many years to come.

FOOD AND NUTRITION, FOOD SCIENCE CLASSES LEARN ABOUT MAPLE INDUSTRY

The Food and Nutrition and Food Science classes taught by Mrs. Obernesser and Mrs. Ives joined together during the week of March 4-8 to learn about the maple industry. Throughout the week students learned about maple production, beginning with identifying maple trees, tapping, sap collection and testing the quality of syrup using brix refractometers and digital maple syrup graders, as well as identifying defects caused by nature. Maple syrup is a completely natural sugar source and is used in a wide variety of recipes other than pancakes.

To finish the week, students toured Delta Glen Maple in Westernville, New York, an operation with over 5,000 taps that is operated by Pete Donahue and Walt Krager. While on the trip, students were able to see sap moving through the lines to the sap house, then to the reverse osmosis process, evaporation and filtration. Donahue and Krager started to boil for the classes in the morning and ended the trip with samples of fresh hot syrup!

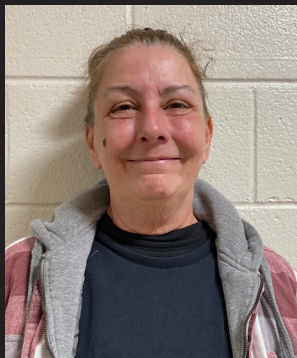

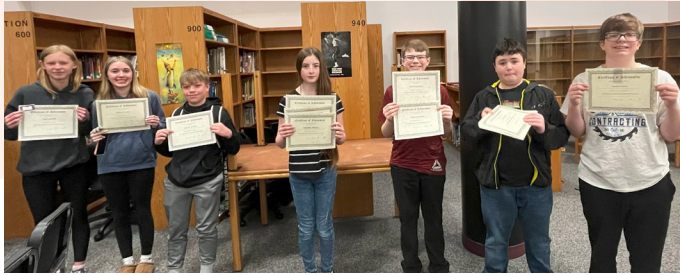

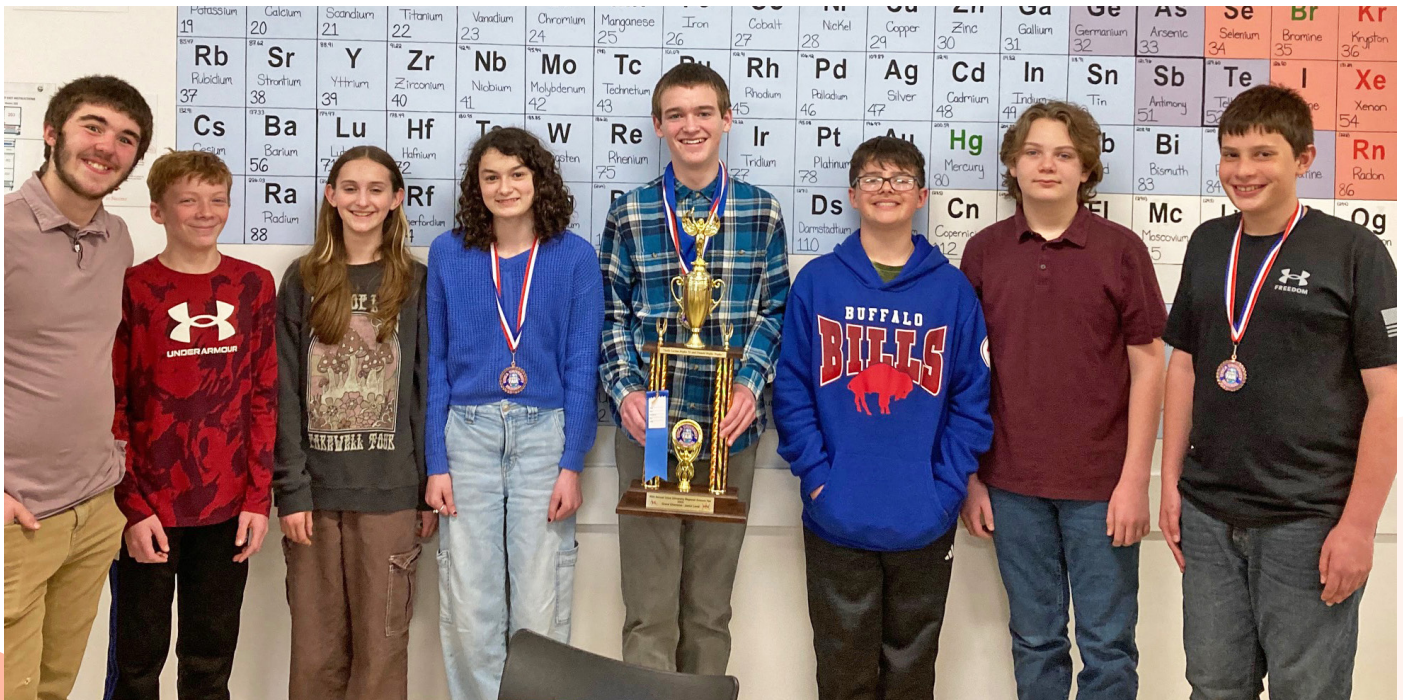
