If you have a student who takes home a Lebanon Community School Corporation (LCSC) MacBook, this letter contains important information about your responsibility and options to repair and/or replace district-owned equipment.

Two of our suppliers have changed pricing so this letter replaces the cost sheet from August 9, 2018. The repair costs are as follows:

Insurance Options

The next option is Worth Avenue Group INC (WAG). been covered by WAG. This information is from page four of WAG insurance policy in the section titled **Losses We Will Not Cover**.
