Project Manager Jaime Ortiz presented an outline of State funding which Tropico Middle School has been approved to receive in May 2023 if they proceed with updated construction plans to build more classrooms as originally planned when the application was submitted approximately 10 years ago.

VII. Reports and Communications

- A. CSEA report: Fallon Mitchell reported on behalf of CSEA Chapter 587. On behalf of some classified staff she reported more communication about frequent changes are requested. Superintendent Gaines acknowledged the questions from CSEA and answered on behalf of the district. RTA report: Jim Quellman requested a larger meeting venue for board meetings. He spoke of negotiations in progress of which RTA has countered proposed.
- B. CBO Report Robert Irving thanked the owners of the new Grocery Outlet for their donation of \$500 of gift cards. He reported on the COVID test increase and the effect it has had on the district COVID team. Additional Sparkletts water dispensers have been ordered for RHS to off set the reduction of available water fountains.
- **C.** Assistant Superintendent Instruction and Curriculum: Leslie Lacey reported on the successful annual William Settlement visits to school sites. She informed the Board of current academics and interventions programs as well as the parent meetings regarding independent study as an alternative school choice.
- **D.** Associate Superintendent Human Resources: Leanne Hargus reported on the progress to fill all the open employment positions with the limited substitute teacher pool.
- **E.** Superintendent Report: Barbara Gaines thanked the audience in attendance through youtube. She appreciated the crossing guards for their invaluable contribution to the students and community. She recognized the difficulty and uncertainty COVID presents for all of us as mandates have changed frequently. Superintendent Gaines spoke of a program "Honor Flight" in which the high school and middle school Cadet Corp will participate in to write a generic letter to a Veteran.
- **F.** Board Member Communications: The Board of Trustees asked for everyone to be flexible as mandates are changed beyond the districts control. The Board asked the district to be transparent with information to the staff and community and appreciate the communications. They asked the football spectators be vigilant to practice better public behavior and to reframe from violence as a method of resolution. The Board thanked the audience watching on youtube.
- **G.** Student Board Member: Alexy Finch, ASB President reported on ASB activities and engaging the students in "Spirt Week" as well as high school "Club Rush" and acknowledging the Cadet Corps participation in the ribbon cutting of the new Grocery Outlet in Rosamond.
