VII. Curriculum and Instruction

A. Title I Performance Evaluation Presentations- *Leslie Lacey*/Westpark Elementary School, *Santiago Meza*/Rosamond Elementary School, and *Dr, Cynthia Bolton*/Tropico Middle School School site administration presented Title I performance results for 2020-2021 and compared progress of past years. The Title I program is a federally funded program reauthorized by the "Every Student Succeeds Act" (ESSA). The State Educational Agency (SEA) shall award grants to geographically diverse local educational agencies (LEAs). The purpose is to ensure all children have a fair, equal, and significant opportunity to obtain a high-quality education and reach minimum proficiency.

- **A**. Expanded Learning Opportunities Grant (ELO)-Superintendent Barbara Gaines presented the focus of the ELO in accordance with AB 86. The focus includes learning, student well-being and provisions for meals. Parent and staff survey data was presented.
