

Requirements for Schools Not Participating in Federal Meal Program

Food and beverage sales outside the district's food service program shall comply with applicable nutritional standards specified in Education Code [49431-49431.7](#) and 5 CCR [15500-15501](#) and [15575-15578](#).

The sale of foods or beverages that do not comply with the standards in Education Code [49431-49431.5](#) may be permitted in either of the following circumstances: (Education Code [49431-49431.5](#))

1. The sale takes place off and away from school premises.
2. The sale takes place on school premises at least one-half hour after the end of the school day.

Requirements for Schools Participating in Federal Meal Program

The National School Lunch and School Breakfast Programs are federally assisted meal programs in public schools. They provide required nutritionally balanced, low-cost or free meals to children each school day.

Temecula Valley Unified School District's Nutrition Services currently covers all of its own expenses without any assistance from the General Fund. It is the District's goal to maintain solvency of the Program for as long as possible. In order to maintain a self-supporting program that does not draw from the General Fund, and to be in compliance with the ever changing federal and state regulations, no food/beverage sales outside of Nutrition Services may occur before or during the school day. PTA/parent groups & ASB's may only sell food/beverages after the school day has ended. However, on four (4) designated days per school year, PTA/parent groups (due to California Competitive Food Rules, ASB's are excluded from this exception) may sell during the instructional day. Any items being sold during this time must be compliant with the Smart Snacks in Schools Guidelines and the California Competitive Food Rules. Each of the four (4) days must be pre-approved by the Nutrition Services Director or Assistant Director.

Any food/beverage sales occurring at the end of the school day and up to 30 minutes after the school day has ended must be compliant with the Smart Snacks in Schools Guidelines and the California Competitive Food Rules. Sales occurring 30 minutes after the school day has ended are not held to the Smart Snacks in Schools Guidelines or the California Competitive Food Rules. PTA/parent groups are responsible for bringing their own supplies, setting up and cleaning up after their sales, and may not store their food items on campus.

The Superintendent or designee shall maintain records, or shall require organizations selling foods and beverages to maintain records, to document compliance with federal nutrition standards for all

competitive foods and beverages sold through and outside the district's food services program. At a minimum, these records shall include receipts, nutrition labels, and/or product specifications. (7 CFR [210.11](#))
