This Hillview Middle School policy describes the means of carrying out designated Title I, Part A parent and family engagement requirements pursuant to ESSA. The Title I school convenes an annual meeting to inform parents of Title I students about Title I, Part A requirements and about the right of parents to be involved in the Title I, Part A program.

Hillview Middle School's Annual Title I meeting is held in the first semester of the school year. Both an in-person and virtual option are provided, as well as the materials being posted online for later review. The community is invited via ParentSquare post.. For those attending synchronously, public comment is taken during the meeting. For those viewing the materials after, an accompanying Google Form is linked to collect feedback. Translation is provided during the meeting. Children are welcome to join the meeting along with their parents.

Parents and family members are notified of the programs supporting students through various means, including the Annual Title I Meeting, weekly phone dialers, email messages, and daily student announcements. This information is also shared at community events such as the SSC, ELAC, PTSA, and Principal's Advisory Council Meetings. The district curriculum is accessible through the district website (https://www.westside.k12.ca.us/departments/educational-services/curriculum). Each year, the MAP NWEA is given three times with family reports being sent home after each administration. Additionally, the CAASPP is given in the Spring with advance notice. The California School Dashboard is publicized when released allowing for more specifics on the challenging State academic standards. Parental input is collected in a variety of ways, including parent teacher conferences, input at ELAC, SSC, and Principal's Advisory Council meetings. Surveys are also used to help gather input into decisions relating to the education of the community's children. Suggestions made in person are immediately responded to when possible and follow up is conducted via phone and email as well as written plans for the future.

Hillview Middle School's Title I, Part A School Parent and Family Engagement Policy was developed jointly and agreed on with parents and family members of children participating in Title I, Part A programs on September 17, 2024. The School will distribute the policy to all parents and family members of participating Title I, Part A students annually on or before September 20, 2024.
