SCHOOL-PARENT COMPACT

School Responsibilities

The Walter Wellborn Elementary School will:

- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:
 - *WWES will hold conferences annually at the convenience of the parent.*
 - *Conferences may be held during teacher's planning time, before or after school.*
 - *Conferences may be requested by the parent or by the school.*
 - *WWES teachers encourage parent conferences.*
- 3. Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:
 - *WWES will provide reports to the parents as required by the Calhoun County grading system.*
 - *Progress reports will be sent home every 4 ½ weeks and Report Cards will be sent home every 9 weeks.*
 - *Daily assignment grades will be sent home on a weekly/bi-weekly basis.*
 - *The school will utilize the school planner to provide reports on child progress.*
 - *The school will provide Powerschool for parents to utilize in regards to student grades.*
- 4. Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:

- *WWES will be available to meet with parents at the parent's request at a scheduled conference time. Teachers may utilize their planning time to meet with parents to discuss specific areas of concern.*
 - *Each teacher has a telephone in the classroom that can receive messages.*
 - *Each teacher has access to the internet that parents can use to communicate with.*
 - *WWES teachers are available at Open House to showcase student progress.*
 - *WWES will utilize Remind to inform parents of important school related information/school activities.*
- 5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:**
- *WWES will utilize volunteers throughout the school year to assist with planned activities within the classroom and school setting.*
 - *Volunteer activities will be assigned through the classroom teachers and the school administration.*
 - *WWES will work closely with PTO to provide opportunities for parents to be involved in school and classroom activities.*
- 6. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.**
- *Teachers and school staff will meet with family members and will communicate in a language that the family understands.*
 - *Teachers and school staff will coordinate with the EL program to provide translation for family members.*
 - *Teachers and school staff will translate information into student and/or family's home language.*
