Open Meetings Act, Section 7.3 Illinois Public Act 97-0609 is an amendment to the Open Meetings Act that requires employers participating in the Illinois Municipal Retirement Fund to post the total compensation package for each contributing employee having a total compensation package that exceeds \$75,000 per year.
