1. **APPLICATION:** Please print and complete the application below.
2. **DEADLINE:** Applications must be received by June 30th.

3. **NOTIFICATION:** The Early Learning Birth to Age Five Scholarship Committee will review all applications and will notify applicants by July 31st.
4. **AGREEMENT:** Applicants who are approved for scholarship funds will receive a scholarship agreement outlining the family expectations, at which time the family may accept or reject the scholarship. The agreement must be signed and returned by August 31st.
5. **LATE APPLICATIONS:** Scholarship applications submitted after June 30th will be considered at the discretion of the Early Learning Birth to Age Five Scholarship Committee.
6. **FINANCIAL:** Our financial assistance fund is limited, and while all requests are considered, we cannot guarantee that all applicants will receive assistance. The decisions of the Early Learning Birth to Age Five Scholarship Committee are based on number of requests, family circumstances, and individual needs.
