5. PRESENTATIONS/AUDIENCE INPUT ON AGENDA

A. Innovative Arts Academy Charter School – Douglas Taylor, Principal of IAACS and Kelly Bauer, Board of Trustees President Mr Taylor and Ms. Bauer were not present and did not provide presentation.

Ann Tarafas, Park Ave., Slatington, PA, Teacher, Innovative Arts Academy Charter School: Provided testimony regarding happenings at the Innovative Arts Academy Charter School (IAACS). When Mr. Gabryluk was present, we had what we needed to provide Special Education services, 2 Teachers and 3 Paraprofessionals. Now, with Mr. Taylor as Principal, we have only 1 Paraprofessional. Mr. Taylor is not concerned about compliance. I feel we are not in compliance, and Ms. Gina Colarusso has been at our

school to monitor and prepare for future PA compliance monitoring. New teachers appear not to have PA certification. Poor treatment of current staff members, not even being invited to the Open House, and not being informed of employment for next year. Students are not getting what they need. Neither existing Special Education teacher has been asked to return. "Very shady." We are out of compliance. We owe compensatory services since we have not provided the appropriate services to our students. Elizabeth Fox, Whitehall, PA, Paraprofessional/Teacher, Innovative Arts Academy Charter School: Provided testimony regarding IAACS and personnel issues. The new Principal is hiring a relative, his partner. There is nepotism occurring. I was not allowed to speak at the last public IAACS Board meeting, being cut off by Mr. Taylor, Principal, after 3 minutes. He is lying to the public regarding the certificates these new people have and other things. Mr. Cavalli, Consultant, hired Mr. Taylor via phone, and he does not have the authority to do this. The Nursing area has been moved and is not ADA compliant. Ms. Fox provided documents of meeting minutes and financial reports. Board members acknowledge receipt of the information and will plan on holding a special meeting to discuss the issues presented this evening with leadership from IAACS. A date will be announced in the near future.
