# A. Approval of 2016-2017 Letter of Agreement for Title I Services with Carbon Lehigh Intermediate Unit #21

The Superintendent requests approval of this agreement with Carbon Lehigh Intermediate Unit 21that identifies the instruction provided by Carbon Lehigh Intermediate Unit at Saint Elizabeth School and St. Thomas More, not to exceed \$2597.88.

# B. In accordance with the Articles of Agreement of the Lehigh Career & Technical Institute (LCTI), it is hereby moved that the Catasauqua Area School District approves LCTI's financing plan in the maximum amount of \$49,000,000 for the purposes set forth in the Resolution presented this evening.
