A. Academics and Education – Christina Lutz-Doemling Christina announced CASD has received Round 3 funding for the Educator in the Workplace Grant in the amount of \$25,000.00. Mr. Bashaw then read the minutes of the meeting, indicating no knowledge that the referenced building is being used or anyone has submitted an intention for use. Additionally, the building has significant structural and safety issue and is not inhabitable. Mr. Bashaw also indicated new LED lights are being considered throughout the Borough.
