\* At this point, the below email and questions were received during tonight's meeting from a community parent:

1. Will masks be limited to solid or patterns? Or are words, symbols, characters ok (so long as they adhere to normal dress code)?

**ANSWER:** Anything that students wear needs to fall into the dress code and that it does not disrupt educational process.

2. I did not hear what the plan is for bus students entering Sheckler. Will they go straight to their classroom?

ANSWER: If they are not eating breakfast, they will go straight to their classroom.

3. In the case of A/B bus runs whether am/pm or both...will parents have more notice than the traditional bus card a week before school starts? I think the difference in time will affect the need for before/after school care.

**ANSWER**: We are planning on seat assignments. If you miss an A run, you will not be able to get onto the B run. Parents will need to answer the bus cards and pick their bus choice. Once picked, it is not a flexible choice.

4. In the case of hybrid learning, will there be a penalty for students unable to attend synchronous instruction? Or will all instruction continue to be recorded for those students without parent supervision (or being cared for at daycare, by a sitter, etc...) at that time to view? **ANSWER:** We do not think for this particular model, there would not be a penalty, maybe a recording would be an option.

5. Does the district plan to hire any supplemental health services staff to assist in the day to day duties of the school nurses? The increased number of student visits anticipated plus the need to keep sick and well students separated will be difficult for one person. Also, school nurses may fall ill themselves due to their exposure. **ANSWER:** This is something that we need to look at and consider.
