Motion by Cunningham, seconded by Hartranft, to authorize Public Financial Management, Inc. to prepare all documents and proceed with pre-market pricing for a potential \$9,995,000 bond issue based on option 3 as presented at the meeting tonight (March 12, 2009); authorize Fox, Rothchild LLP as bond counsel and David Knerr as solicitor to work with them; and authorize the Superintendent, Robert J. Spengler, and Business Supervisor, Lois Reed, to provide all necessary information to those professionals, so that they may present a resolution for the Board to consider at its April 14, 2009 meeting to incur the debt.

In addition, if the board does not authorize a bond issue to finance the Sheckler project at the next meeting, MKSD shall be entitled to payment for the design services up to that point in time in accordance with MKSD's hourly pricing schedule in its most recent contract with the district.
