## Schools Begin Transition from Continuity of Learning Plan to New Instruction for All Classes

Now that it is clear the Cherry Hill Public Schools will be closed until at least April 20, 2020 – and this timetable remains at the will of Gov. Phil Murphy – our students' online learning will transition to new instruction for all classes. Please refer to the email from your building principal for specific details and schedules.

Please understand that the focus for the instruction is on your child's *learning*, not on grades.

### Meal Distribution Sites Added for Families Who Qualify for Free/Reduced Price Meals

Distribution of meals to ALL FAMILIES IN THE DISTRICT WHO QUALIFY FOR FREE/REDUCED PRICE MEALS will continue the week of March 30, 2020 with new locations added. On Monday, March 30, qualifying students will receive 3 breakfasts and 3 lunches per student. On Thursday, April 2, qualifying students will receive 2 breakfasts and 2 lunches per student. Meals may be picked up at any of the following five locations:

- Cherry Hill High School East from 10 am to noon
- Cherry Hill High School West from 10 am to noon
- · Clara Barton Elementary School from 10 am to noon
- Barlow Park on Victor Avenue, just off Church Road, from 10 to 10:45 am
- Carusi Middle School from 11:15 am to noon
