

Highlights from the July 23, 2019 Action Meeting

Board Representative Reports

Cherry Hill High School West Alternate Representative Jack Begley reported that fall sports practices had begun, and mentioned specific programs for the girls' LaCrosse and Soccer Teams, developed by the teams' respective coaches. He closed with, "Everyone's off for the summer, except us," referencing himself, the Board and Administration.

No representatives from Cherry Hill High School East were present, and no reports were submitted from East.

The Board approved attendance at conferences and workshops for the 2019-2020 school year.

The Board approved Out of District Students Placement for the 2019-2020 School Year.
