Highlights from the June 2018 Action Meeting

Board Representative Reports

Cherry Hill High School West Representative Sonia Kangaju gave a “school climate” report from interviewing 18 students at Cherry Hill West. She summarized that most of those surveys reported a positive experience with academic and emotional support. She reported that several students were not happy with the condition of the high school building. She noted that plans for improvements included in the upcoming bond referendum for facilities not just at West, but throughout the District, would likely “help to assuage some of those complaints.” She added that extracurricular programs were strong, but some student athletes would like their programs to be more visibly supported and publicized.

Cherry Hill High School East Representative Julia Langmuir noted the success of the East Senior Prom, as well as the yearbook signing party, a skate night, the Cherry Hill Education Foundation-sponsored Academic Brunch, Graduation and Project Graduation. She added that the rest of school community had been busy as well, with the fourth and final free Movie Night of the year on the last regular day of classes, final exams, the close of the spring sports season, Thespian Society inductions, Senior Solo Night and summer athletic and academic activities. She noted that students are looking forward to the start of school in the fall.
