

# Highlights from the February 2018 Action Meeting

### **Presentations**

The Cherry Hill African American Civic Association presented awards in their Poster/Video/Essay Contest, with the theme "African-Americans in STEM (Science, Technology, Engineering and Mathematics)," to students in all grade levels. The Cherry Hill High School East Theater department provided a video preview of their upcoming musical, *The Music Man*. CHPS Director of Curriculum Dr. Farrah Mahan presented the School Performance Reports.

### **Board Representative Reports**

Cherry Hill High School East Alternate Representative Lauren Atkin reported that East activities were in full swing, including the sophomore class Cotillion, the DECA state competition, the teachers' shoe decorating contest to raise money for the American Heart Association, rehearsals for the spring musical, The Music Man, a successful end to the boys and girls swim seasons, and the Wing Bowl. Ms. Atkin noted that East's cultural clubs were preparing for Multicultural Day, and that three robotics teams had qualified for the World Championship competition in April. Ms. Atkin added that she "found it necessary to talk a little bit about current protests at East." She noted that many students had come to the Board meeting to speak during public comment and asked the Board to "take their testimonies to heart." She also said that security was "at the core of this issue" and asked that action be taken now.

Cherry Hill High School West Alternate Representative Gay Brown reported that *Still Rising* was presented at Cherry Hill High School West as a multi-faceted celebration of Black History for Black History Month. She noted that the Teen Scene Social was held for special needs students. She added that the West Interact Club had partnered with Cherry Hill Rotary to collect feminine hygiene products to be donate through Distributing

Dignity, a nonprofit organization dedicated to helping women in need. Currently, she said, the Interact Club and Rotary were working together in a coin drive for the Ronald McDonald Houses in South Jersey, Pennsylvania and Delaware. She also described West's African American Culture Club's recent live African American Museum that brought black history to life. She noted that the Peer Leaders Program held interviews for the 2018-2019 Peer Leader group. She also gave the dates for Broadway Night, Sophomore Cotillion, and the spring musical, The Phantom of the Opera. Ms. Brown noted that the show's director, Mrs. Carolyn Messias, had been nominated for the Teacher of Excellence Tony Award, and Mr. Zach Semar was named Wrestling Coach of the Year. She closed her report by noting that the West sports teams were competing with pride and enthusiasm demonstrating sportsmanship and the West Way.

The Board approved a five-year amendment of the Long –Range Facilities Plan.

The Board approved a McKinney-Vento student to go out of district for the 2017-2018 school year.

The Board approved the award of change orders for site improvements as detailed in the Action Agenda.
