

# Highlights from the September 2017 Action Meeting

# **Presentations**

The Board of Education welcomed the new staff members of the Cherry Hill Public Schools.

### **Board Representative Reports**

Cherry Hill High School West Representative Carlee Cohen reported on the multiple activities taking place during the first three weeks of school. She noted that as classes resumed on September 5, the school ran a modified schedule so that students could attend all of their classes the first day. Ms. Cohen said that West Peer Leaders had been assigned to freshman homerooms to welcome the class of 2021 and would continue to visit the homerooms every day for the first cycle of the year. She mentioned West's Fall Athletics Night and the Fall Sports Luncheon, at which Athletic Director Mr. Beirao led discussions with the team captains about leading their teams and exhibiting the "West way." Ms. Cohen noted that September 14 had been Back to School Night. She added that upcoming events include the West Girls Soccer Team Car Wash on September 30 the PSATs on October 11. She concluded her report with an announcement that the West Guidance Department would be holding a College Application seminar on September 28.

Cherry Hill High School East Representative Joshua Sodicoff reported about Freshman Orientation and the first day of school. He noted that construction continued around the courtyard. He mentioned a new 7:15 am bell and its limited success at clearing the hallways before the 7:25 class bell. He added that an increasing number of new clubs have been established, and communication about the clubs and activities has improved this year. He reported on the success of Back to School Night and mentioned the upcoming Financial Aid Night and the senior trip information night.

### **Curriculum & Instruction**

The Board approved attendance at conferences and workshops for the 2017-2018 school year.

The Board approved out of district student placements for the 2017-2018 school year.

The Board approved a Professional Services Agreement.

# **Business & Facilities**

The Board approved the financial reports for July 2017, including the Board Secretary's Certification and Treasurer's Report, the Line Item Transfer Report, the Food Service Operating Statement, and the SACC Financial Report. The Board approved the disbursement of funds in the amount of \$ 13,247,950.70.
