

# Highlights from the July 2017 Action Meeting

# **Board Representative Reports**

Cherry Hill High School West Representative Carlee Cohen spoke about the West Guidance Departmen Common App/Naviance workshop on July 13, with another coming up on August 8. She noted that voluntary practices for fall sports are continuing through July, and that tryouts for fall sports, besides football, will resume August 14.

Cherry Hill High School East Representative Joshua Sodicoff reported about the addition of "High School 101" workshops to the traditional orientation meetings. He noted that new student tours also were being offered on three dates in August, prior to orientation on the 31<sup>st</sup>. Mr. Sodicoff lauded the change in the high school summer reading assignments, giving students more interesting options for the types of assignments accepted. Mr. Sodicoff also mentioned the August 26 SAT date and the fact that the Common App opens on August 1.

The Board approved a resolution for the award of bids for student transportation services and school related activites/athletics for the 2017-2018 school year.

The Board approved a resolution to modify the 2017-2018 General Fund Budget for Additional State Aid Received, as outlined in the July 25, 2017 Action Meeting Agenda.

The Board approved a settlement agreement with former employee number 11994.

The Board approved multiple awards of transportation as detailed in the July 25, 2017 Action Meeting agenda.

The Board accepted Non Public Textbook Aid for the 2017-18 school year in the amount of \$54.78 per student, for a total award of \$80,911.

The Board accepted Non Public Nursing Aid for the 2017-18 school year in the amount of \$97.00 per student, for a total award of \$152,193.

The Board accepted Non Public Technology Aid for the 2017-18 school year in the amount of \$37.00 per student, for a total award of \$54,649.
