

Highlights from the May 2017 Action Meeting

Presentations

Students from Cherry Hill High School West who completed the school's first Virtua Interns program, a hands-on health care career study program, presented an overview of the program to the Board. Dr. Meloche and Mrs. Shugars presented the latest CHPS 2020: A Clear Vision for the Future plan.

Board Representative Reports

Cherry Hill High School West Representative Molly Burch reported about year-end activities at West, including the annual International Cook Off. She noted that Hall of Fame inductions had taken place, with 11 students named. Ms. Burch reported that West's annual blood drive had taken place today. She also commented on her participation in the Virtua Intern program, noting its tremendous impact which "will affect me throughout my life." She added that she would like to see the program expand to engineering and other fields. Ms. Burch mentioned the upcoming Senoir Prom at the Adventure Aquarium, as well as Graduation and Project Graduation. She closed by saying the Class of 2017 was very proud of their accomplishments and hoped have created a positive impact on the community.

Cherry Hill High School East Representative Kaitlyn Boyle reported that East seniors are excited for the end of the year activities. She noted that Senior Prom at the Vie would be the same day as West's Senior Prom. Ms. Boyle noted the last issue of Eastside would include "Senior Superlatives" and "Teacher Superlatives." She added that many East students had qualified for National Merit recognition and two had received \$2,500 merit scholarships. She mentioned Movie Night Under the Stars, the first event of its kind developed by the SGA. She also noted the blood drive today and the upcoming PAVAS Art Show. Ms. Boyle closed her comments by

saying it has been an honor to represent the East student body, and extended her thanks to "all of you" for the opportunity to offer student opinions. "Please continue to engage students," she said.
