## **Board Representative Reports**

No student representative from Cherry Hill High School East was in attendance at this meeting. Cherry Hill High School West Alternate Student Representative Abby Spencer noted that she was excited to be chosen as the Alternative Student Representative from West. She also said she hoped everyone was staying cool during the current heat wave. Ms. Spencer also said that captains' practices had begun for soccer, football, tennis, volleyball and field hockey, noted that she is one of the senior captains for field hockey. Ms. Spencer added that she recently got to step on the turf field with Cherry Hill West Athletic Director, Mr. Lou Papa. She noted that the Cherry Hill West peer leaders were preparing to go to Camp Ockanickon and that students also were beginning their summer reading. She closed by saying the class of 2017 was preparing to begin their exciting senior year.

The Board approved contract renewals for the 2016-2017 school year to be operated by their respective contractors for public, special education and AIL Choice.

The Board approved Change Order 001 to be issued to Fred M. Schiavone Construction, Inc., to deduct \$4,000.00 from the cost of work at Bret Harte Elementary School.

The Board approved the agreement between the Cherry Hill Board of Education ("Board") and Carmen DiTore ("Contractor") – Cherry Hill Investigative Services for the Provision of Student Residency Investigation Services ("Services from July 1, 2016 through June 30, 2017") in the amount not to exceed Fifteen Thousand Five Hundred Dollars (\$15,500).

The Board accepted the following donations:

A monetary donation from Barclay PTA for a SmartBoard purchased through Scholastic to Barclay Early Childhood Center: \$3,000.

A monetary donation from Barclay PTA for Proxima and installation of SmartBoard to Barclay Early Childhood Center: \$3,359.
