

Highlights from the January 2016 Action Meeting

Presentations

Dr. Meloche noted that January was School Board Recognition Month, and thanked the volunteer members of the Cherry Hill Board of Education for their service.

Board Representative Reports

Cherry Hill High School East student representative Drew Meklinsky congratulated the newly sworn in Board members, Dr. Dickinson, Mrs. Judge, Mrs. Scarpellino and Mr. Tomlinson on their positions. He described East's Freshman Dance in January as "amazing." Mr. Meklinsky also mentioned East's recent Lip Sync Battle, resurrected after ending in the early '90s - nearly 300 people attended the event. Mr. Meklinsky mentioned East's a cappella group Stay Tuned's participation in the television show "Pitch Slapped." He made note of the upcoming Kaleidoscope concert and Sophomore Cotillion. Mr. Meklinsky also noted that the Mr. East competition was in the planning stages and would be one of the biggest events of the Class of 2016's senior year. He finished his report by mentioning that East's Open House for incoming freshman would take place Thursday, January 28, at 7 pm.

Cherry Hill High School West alternate student representative Justin Gick welcomed the new Board members. He then thanked Dr. Meloche for the recent 2hour delay because of inclement weather. Mr. Gick mentioned that "many exciting things" were happening at West during the month of January, including the East vs. West swim meet, which he thanked Dr. Meloche, Mrs. Judge, Mrs. Wilson and Mr. Papa for attending. He noted that the West boys' basketball team was doing "awesome." Mr. Gick also noted that the Lion's Roar staff was working the Jan/Feb issue of the newspaper, and that West Lab Theater's Laramie Project had been rescheduled for the upcoming weekend. West's musical theater production, The Little Mermaid, he added, had begun rehearsals. Mr. Gick also talked about Congressional candidate Alex Law's visit to West's Government class. West also was looking forward to its eighth grade orientation session on January 27, he noted. Mr. Gick said the Rock Your Socks campaign would

continue through the end of January, while the DECA NJ Gold Conference resulted in 80 students advancing to states. Mr. Gick wrapped up his report by noting that West's new video announcements would begin airing the week of February 1. He thanked the Board for nearing the end of CHEA negotiations.
