# **Touching Base**

School Conference Week is a crucial time for our families to have important conversations with their middle and elementary children's teachers.

This last week of November marked "Conference Week" in our middle and elementary schools. It's a week that I always looked forward to as a parent when my children were younger, as an elementary and then middle school principal earlier in my career, and now as superintendent. The student led conference format we use in our elementary schools is fantastic outlet for student voice! In these interactions, such as the student led conference at Johnson Elementary, pictured above, students have the opportunity to contemplate their own part in their learning. They are able to lead the conversations with their both their parents and their teachers, to collaborate on solutions where challenges are present and to celebrate specific successes.

The insight and valuable feedback from conferences sets our students on a course for success as they move up through grade levels, and even through their high school careers. Conferences are one of the best ways for parents to touch base with their children's teachers, to gain a better understanding of the hows and whys of their children's school experience, and to forge a collaborative relationship with the teachers and the school district at large.

As we begin the busy month of December, please be sure to become as informed as you possibly can about what's going on in the District, especially as we approach the December 11 Special Election for the Bond Referendum, with polls open that day from 3-8 pm and vote by mail and early voting as options. As I have explained previously, bonds are a way for school districts to raise money – which they then must pay back over a period of years – typically to finance building projects or other capital projects. Although we and the administrators, Board of Education members, and concerned citizens of the community before us have vigorously sought the funding we are owed from the state for decades, our

lack of state funding has forced us to make tough choices. We have chosen to maintain small classes, important programs and quality staff. What little money has been left, even after using grant funding, has not been enough to fully cover our needed facilities improvements. We continue to fight to secure our fair share of funding, but even when we finally receive the \$29 million we should annually, our needs will far exceed those funds. I encourage you to visit our Bond 2018: Building a Solid Future page on the District web site for information about the Bond, including a recently added link to Bond Referendum project costs at a glance, as well as projects listed by school, frequently asked questions, and a tax impact calculator to estimate the effect of the Bond on your property taxes. The Bond 2018 page is updated regularly, so be sure to check back in the coming weeks for additional information. I also would be happy to speak to any group in the community, no matter how large or small, about the Bond.
