# The Importance of Being Informed

With Election Day less than four weeks away and changes afoot with PARCC testing requirements, knowledge is a more valuable tool than ever.

In the Cherry Hill Public Schools, we champion curiosity as a crucial part of success in learning. We want our students to be lifelong learners, to carry their curiosity well into adulthood and to continually seek a better understanding of the world around them. With this, we hope, naturally comes a desire to contribute to society in a meaningful way.

One significant way for adults to contribute to their community and their country is to vote on November 8. Although many would agree this election season has been tumultuous, it has presented us as educators and as parents with many "teachable moments." Beyond the presidential election on November 8 are local elections not the least of which is the race for three open seats on the Cherry Hill Board of Education. Be sure to register to vote by the October 18 registration deadline if you haven't already. This year, seven candidates are vying for three open seats. I encourage you to read the bios submitted by each of the candidates and posted on our District web site. Mark your calendars, too, for the BOE Candidates' Forum on October 19 at Rosa Middle School, detailed in the story below at left. The forum is your chance to submit questions for the candidates to answer. If you can't make it to the event, you may watch it on your computer or other personal electronic device, as it will be streamed live via the District web site.

I also would like to remind you about important changes taking place with regard to PARCC testing. Beginning with the class of 2020 (our current 9th graders) and beyond, students will be required to sit for the assessment – **there will not be an option to refuse the test**. #### BOE Candidates' Forum Set for October 19; Bios Available on District Web Site

Community members are encouraged to bring their questions for the seven Board of Education candidates to the Cherry Hill Zone PTA's Board of Education Candidates' Forum on Wednesday, October 19 at Rosa International Middle School. Doors will open at 7 pm and attendees may submit their questions in writing at that time.

The candidates, in ballot order, are: Ruth Schultz, Ian Morris, Edward Wang, Steven C. Robbins, Fredrick Dande, Joseph Gerace and Jane Scarpellino.



#### New State PARCC Assessment Requirements Will Eliminate Testing Refusal

Under new state guidelines, students in the class of 2020 (current 9th graders) and beyond no longer will be able to refuse to take the annual PARCC State Assessments.

According to New Jersey Department of Education guidelines, current 9th grade students must take the PARCC English Language Arts (ELA) Grade 9 test this year. They also will be required to take their grade level PARCC ELA test in 10th and in 11th grade. If a passing score is not met on any one of these three tests, the student may take one of the state approved alternate tests to fulfill their graduation requirement. A list of the accepted alternate tests may be found on the "PARCC Results 2016" presentation posted on the District web site.

Likewise, current 9th grade students must take PARCC Algebra I, PARCC Geometry and PARCC Algebra II at their appropriate grade level. If a passing score is not met on any one of these three tests, the student may take one of the state approved alternate tests to fulfill their graduation requirement. A list of the



#### Community Service Hours Sign-up Available at Harvest Festival

The Cherry Hill Food Pantry is looking for student volunteers and will sign for community service hours for those students. Student volunteers are encouraged to visit the Food Pantry tent at the Harvest Festival this Sunday, October 16 at Croft Farm, where they may sign up to volunteer with the organization.

The Harvest Festival, featuring Fire & Life Safety Day, will take place from noon-4 pm. Presented jointly by Cherry Hill Township, Cherry Hill Police Department and Cherry Hill Fire Department, the festival offers food, entertainment and educational presentations for all ages.

#### accepted alternate tests may be found on the "PARCC Results 2016" presentation posted on the District web site.

Students in the class of 2021 and beyond (grades 8 and younger) are required to take the PARCC ELA in grade 9, grade 10 and grade 11. If a passing score is not met on the PARCC ELA grade 10, no alternate test will be accepted. The student without a passing score in grade 10 must instead meet the criteria of the NJ Department of Education Portfolio Appeal.

Likewise, class of 2021 students and beyond must take PARCC Algebra I, PARCC Geometry and PARCC Algebra II at their appropriate grade level. If a passing score is not met on PARCC Algebra I, the student must instead meet the criteria of the NJ Department of Education Portfolio Appeal.
