We thank you for your dedication to our University's services regarding our current School Physician contract with Lawnside Public School District. Our current agreement auto-renewed July 1, 2022 through June 30, 2023.

This letter is to notify you of the COLA increase amounts effective July 1, 2022 through June 30, 2023. After reviewing, the current CPI trends for 2022, we have concluded that the COLA percentage will increase the contract amounts by 3.0%. The total annual amount for administrative services and mileage effective July 1, 2022 is \$2,853.83.

The new totals are outlined below:

- **Administrative Services: \$2836.92** (Previously \$2,754.24) \$236.41 per hour up to 12 hours.
- **Mileage 27.2 miles** (at the 2022 IRS Rate of \$0.585) = \$15.91
- **Services provided at School: \$236.41** (Previously \$229.52)
- **Services provided at University office: \$236.41** (Previously \$229.52)


