The District's Fund Balance as of 6/30/2021 \$3.5mm with \$625 unassigned excess surplus of which \$1.6 mm was utilized for 2022 school year budget. The district continues to have \$400,000 in Tuition Reserves and \$300,000 in Maintenance Reserve.
