9. Public Comments - Mr. Ervin Mears - 411 E. Charleston Avenue, Lawnside NJ

Mr. Mears stated that the \$13,000.00 generated from the lawsuit due to lack of response from a previous OPRA Request is not coming to him, but are his lawyer fees. Mr. Mears wanted to clarify from the last board meeting that he personally wasn't suing the district for his gain but the dollar amount that was mentioned at the previous board meeting and statement was incorrect.

a. Mr. Mears also explained how an OPRA Request is supposed to be addressed within a seven (7) days ppf receiving the OPRA Request and that he has the right to sue in order to obtain the information requested.

Mr. Mears also expressed that he was informed by his attorney that the School District's attorney and the Board President indicated that she wasn't paying me (Mears) a dime.

Board President Response - Explained that all matters are brought to the Board's attention, that decisions that are made are not solely rest upon her.

Personally she believes that Mr. Mears should be ashamed of himself for taking any funds away from the school district.

She understands the process of an OPRA Request, however the information that you requested was during the pandemic and the Governor passed an Executive Order to address OPRA Request during this time period.

b. Ms. Michelle Carter - 15 Hemingway Drive, Lawnside New Jersey

Ms. Carter is concerned about the lack of transportation for the High School students to and from and the extracurricular activities. One (1) bus is simply not enough, due to overcrowdedness. She wanted to know if the school district could partner up with a community organization or a church to provide the transportation needed for the students?

Board President Response: Thanked Ms. Carter for her concerns and advised her that the District is currently working on addressing this issue with the submission of the application to the County Superintendent requesting a waiver for the parents to drive their children to school.

11. Board Comments:

Mr. Bass - Exhausted with the discussion regarding the lawsuit, which has nothing to do with our children and education.

Ms. Wilson - Congratulations to everyone who won the election and especially to Ms. Forrest. She also expressed that she believes that the new members are the right team for the school district.

Ms. Wright - Wanted to comment on the concern that Ms. Whitley had from the previous board meeting. Station Place Apartment is a one to two bedroom apartment and there are a total of 144 apartments in total. Given these facts, there is no way 200-300 children will be attending our school. Ms. Wright also wanted to speak to Mr. Mears regarding the lawsuit and the current process regarding an OPRA Request.

Mr. Rhone (Board Solitaire) - recommended that Board members shouldn't speak to any matter concerning the current lawsuit.

Ms. Warlow-Hurley - wanted to know if she had put an OPRA Request to find out the final cost of the lawsuit?

Mr. Rhone - Informed Ms. Warlow-Hurley she can go to the county court to get a copy of the record.

Ms. Wright - wanted to know how to proceed to address a board member that has been missing meetings.

Mr. Rhone - Informed the Board Members that they can proceed with a resolution and vote on having the individual to be removed from the Board.

Ms. Wright motioned to have Mr. Phoenix Moore removed from the Lawnside School District Board who has missed over 5 meetings

CESSATION OF BOARD MEMBERSHIP -PHOENIX MOORE

WHEREAS, Phoenix Moore is a school official, as defined in the School Ethics Act, serving as a Board member of the Lawnside School District's Board of Education, located in Camden County; and

WHEREAS, New Jersey law, pursuant to N.J.S.A. 18A:12-3 provides that a member of a board of education, via a board's action of removal, may cease to be a member of such board upon said member's failure to attend three (3) consecutive meetings of the board without good cause; and

WHEREAS, Phoenix Moore, having missed five (5) consecutive Board of Education meetings – without providing good cause, stated excuse, notification, legal or technical reasons, or any other

response to continued verbal, written, and electronic outreach and correspondence regarding his status, attendance and availability; and

WHEREAS, the above, taken in further context with a record of chronic absenteeism from the Board, and a factual inability of the Board to obtain quorum for scheduled meetings — a reasonable examination of such actions and lack of response from Phoenix Moore to any and all good faith Board notices regarding continued absences would find such consistent with an act of abandonment, with no necessary consideration to underlying purpose or intent in the absence of good cause and lack of responsive; and

WHEREAS, the Board, having given due consideration to all provided evidence – inclusive of approved Board minutes, records of attendance; and Board correspondence; so

MAY THEREFORE BE IT RESOLVED, that the Board adopts the herein Resolution REMOVING Phoenix Moore, pursuant to the provisions of N.J.S.A. 18:A-12-3, as so is consistent with the facts and legislative intent of the statute.
