# Public Comments at 7:33 p.m.

Mr. Lloyd Henderson of 225 Miller Ave in Lawnside commented on the superintendent's report. He congratulated Dr. Johnson on the "Black History Month Program" He stated Cherry Hill School District has a mandate where Black History is required for graduation. He stated when he was a board member he asked the board to make Black History mandatory. He also said if a white school district can make it a requirement, then why can't Lawnside make it a requirement for eighth graders. So that when they attend Haddon Heights or Vocational School, they will have some background on achievement and productivity. The suggestion was made 15 years ago.

Mr. Lewis asked if the "public comments" needed to be on a resolution item. Mrs. Forrest stated, yes at this point. The second public comment is for any non-agenda item.

Correspondence - Ms. Leary read a "letter of interest" received from Amy Kearney

Mr. M. Mears of Lawnside asked if there was a notice sent out, and how was she aware that there was a vacancy. Mrs. Forrest stated, the vacant seat has been mentioned at the board meetings for awhile.

Mrs. Forrest asked Ms. Leary about board member training. Ms. Leary informed the board members that they were all registered for their online training and said December 31, 2021 is the deadline.

#### **Committee Reports**

Haddon Heights Representative – Ms. Alexis Wilson stated she attended Haddon Heights Board Meeting on Tuesday. There were nothing to report for Lawnside. She sadly reported the passing of a seventh grade student and said students are having trouble adjusting. She said keep everyone in your praise. Mrs. Forrest thanked Ms. Wilson for representing the Lawnside Board.

Camden County Representative - Mrs. Forrest serves on the Board of Directors. She stated there was a budget meeting in February and in March the audit was reviewed.

Ms. Wright asked Mrs. Forrest when Committees would be assigned. Mrs. Forrest stated she would finish today and had two left to assign.

Mr. M. Mears, a Lawnside resident stated he noticed there was an increase in the budget for 1.2 million. Mrs. Forrest stated the budget is made up of several factors and everything is counted. When there is money from the State it is included. The auditor reviewed the budget. Ms. Leary explained the budget process in greater detail. Mr. Mears asked what percentage contributes to the 1.2 million dollar increase. Mrs. Forrest stated there is not a 1.2 million dollar increase. She asked him if he was talking about the budget. She stated the budget is the kitty of the money. Mr. M. Mears said he was referring to resolution #31. He said he was trying to get a better understanding. Mrs. Forrest stated resolution #31 is just the submission to the County Office. Mrs. Forrest stated we have federal grants, state aid and money that was budgeted but not spent. All funds need to be included. The only percentages we deal with is the tax levy percentages. Dr. Johnson stated Mr. Mears question is reflected during the budget presentation and when we do the breakdown. Ms. Leary reviews and discusses the budget with the board. The first part is to submit a preliminary budget to the County Office to get approval to bring the budget before the board to discuss and then present to the public at the public hearing. The question should be answered in the next month or two. Mr. Mears asked if board members participate in the makeup of the budget. Mrs. Forrest answered "no". It is not the board members job to make up the budget.

Public Comments at 7:58 p.m.

Celeste Brown of 79 LaPierre Ave in Lawnside said it was good to be back and see everyone. She also said she was on dialysis and her household was hit hard with COVID-19 the week of Thanksgiving. She stated her 90 year old mother passed. She thanked Dr. Johnson and the school board. She is very proud of the city and gave "kudos" to Dr. Johnson, teachers and the school board for all of their hard work. Remember our main focus and objective is the children. Mrs. Forrest thanked Ms. Brown and offered her condolences for her loss.

Mr. Ervin Mears of 411 E. Charleston Ave in Lawnside congratulated Mr. Moore and Ms. Catlett on becoming board members. He stated he listened to Mr. Lloyd Henderson speak regarding Black History Month. It's not a good day, it's a sad day. He went on to say the two new board members, Mr. Moore and Ms. Catlett had to obtain an attorney to be seated. We had to go to the white folks and ask them to insured they were seated. They were qualified in January. Ms. Catlett's fingerprints were approved on February 2<sup>nd</sup>. It didn't look right, black folks running up to white folks telling them to enforce the seating of two duly elected school board members. Next issue, the school board has not collected the \$17,500 from the teachers who underpaid in Health Benefits last year (18A:16-17-1). The same law that we used for board members to be installed in January for the health benefits. You have to collect the money. If the board doesn't collect the taxpayers money, he will file a complaint with the Department of Education. The board has the right duty, and responsibility to look after the taxpayers money. He said this issue was brought up before and never addressed. Mrs. Forrest stated the \$17,500 issue was entertained months ago. Ms. Leary can check the minutes to see when action was taken. Secondly, she was advised by the State of New Jersey, Department of Education that fingerprints have to be cleared. The State was back logged with results due to COVID-19. Mrs. Forrest said she wants to make it publicly known that the board did nothing wrong. She asked Mr. Gordon, technology coordinator, to placed Mr. Mears on mute due to constant interruptions. She said it was very inappropriate to ask a question, interrupt and then have a temper tantrum when you do not hear what you want to hear. She said she is only going to speak the truth. She also said, she functions on direction given by the Department of Education. We cannot seat board members until we have results. Mrs. Forrest explained the same process took place with Ms. Cauthorne where there was a waiting period. She said "this is not her board". This is about the students. We function as a full board. We need to come together. We're not hurting anyone but the kids.

Chris Lewis of 316 Ellis Court in Lawnside, stated, he presently lives in Florida. He said there was a request sent to the board regarding the renaming of the gym to "Carlton Perry" who was his brother. He was a coach and did a lot for Lawnside. His understanding is that the request was denied. He asked the board, "What could be done for all the others who gave contributions such as: Mr. Gaines, Ms. Smith and of course, Carlton Perry? All gave incredible contributions to Lawnside. Mr. Lewis said He was in the first kindergarten class at the school. Currently, he is a Risk Manager in Florida working for 15 municipalities, including school boards and counties. Board of Education members need to be aware of the rules so that meetings can run more smoothly. When time is taken away to explain the rules, it takes time away from other business. Mrs. Forrest gave her condolences to Mr. Lewis. She said the Outreach Committee consist of Ms. Nana Cauthorne who is the chairperson and Alexis Wilson. They can contact him when there is a meeting. Conversations did take place regarding other proposals to recognize others in the community. As stated by Ms. Celeste Brown, "Lawnside is a wonderful community. Mrs. Forrest asked Ms. Cauthorne if she wanted to speak. Ms. Cauthorne stated something will be done for Carlton and everyone else.

Councilwoman Rhonda Wardlow Hurley stated, "Just for the record, councilwoman Wardlow-Hurley made the request to rename the gym, not the Mayor. Mayor and Council have decided to honor Carlton another way. She stated she attended a meeting at Haddon Heights. We need to stop the foolishness, for a small community. We are trying to move forward. It's ridiculous. The business needs to be about the children. Stop the personal attacks. A young student took their own life. She hopes people are honored like: Carlton, Ms. Sissy and Mr. Gaines. We should honor people for work they do before they close their eyes.

Lavinia Taylor of 23 E. Emlen Ave in Lawnside stated she was very impressed with the Black History Month project. Friends were jealous. It was a very good activity. Her children were born and raised in Lawnside. The program was an eye opener. Children were actively involved. Kudos to the board. A lot of hard work and effort went into the program.

Ms. Celeste Brown of Lawnside said even though the PTA has not been active due to the pandemic she still is very supportive and help financially. Mrs. Forrest stated she will provide Ms. Brown's phone number to Ms. Leary to give to the teachers in case they need any support.

Ms. Shamele Jordan said to Ms. Taylor, she would love to go to Camden to do a program.

Board Member Comments at 8:18 p.m.

Mr. Phoenix Moore thanked Ms. Shamele Jordan for the Black History Month Project. He said he was inspired. Good job well done. With regards to the young child who took their own life, he said he grew up thinking he was a little special. He had friends who lost their lives. The school board shapes and forms the weird children. He apologized and said special students. It would be incredible to start a program where students can become creative.

Ms. Marsharee Wright congratulated the new board member, Mr. Moore and Ms. Catlett and welcomed them to the board. She said, "Buckle up, there is a lot of work to do". With regards to the open board seat, a vacancy notice should be sent to the community. She thanked Ms. Higgs and Mr. Jordan on the Black History Month Program. There was an event on February 20<sup>th</sup> "NJ Hook up on Black Women held a virtual event where 40% of participates were Lawnside Student. Student received a \$20 gift card. Eighth grade parents need to reach out to Norman Alston and Ayree Stevenson No school next Friday, hopefully parents can plan something fun to do. On April 3<sup>rd</sup>, the Borough

of Lawnside will be hosting "Clean Up Lawnside Activity". Can contact councilman Pollard.

Mr. M. Mears stated in regards to board members being prepared, he would like to make a motion to make sure all board members are provided with a hard copy of Title 18A and a mandated policy book. He went on to read a prepared written correspondence and said it was obvious that the board president, board secretary and board solicitor have failed to be honest and forth coming with information on the law and decision making. This will ensure that all members are equipped and have access to the laws that govern the school district. We have voting on things in the past that have been illegal. The board solicitor had advised the board on issues that later ended in legal trouble. To avoid this, provide information to new board members. Ms. Wright said he has to make sure it is okay to add it to the agenda first. Mr. Mears said let's ask our school board solicitor. Ms. Wright said "yes" let's ask Mr. Rhone, for "Mr. Pay Attention". Mr. Rhone, board solicitor apologized to the guest and board members. He said school boards conducted a training. Ethics require school board members to provide correct information. They are laws regarding defamation and certain standards and such. He said he has a very thick skin as many people do. He stated he knows Mr. Mears is being sculpted by his mentor. As a point of concern, be careful about what you read and where you get it from. He told Mr. M. Mears to be careful. Mrs. Forrest stated Mr. Mears concerns will be addressed at another time. Mr. Moore said as a new member, he has been searching for information for new board members. He said he would like to second the motion so he doesn't step on anyone's toes. Mrs. Forrest stated as Ms. Wright said, there's no motion on the floor. That is something that would have to be added. She also Mr. Mears was being rude and several people are on the call. Mrs. Forrest went on to said, we have explained the budget in-depth and it's ironic that your screen name is "Pay Attention" and you don't pay attention. We have reviewed the budget in great detail. Mrs. Forrest said we have members who work and take time out. Everyone has a family. We need to realize when a question is asked, be kind enough to be quiet and receive the answer. We don't always get along, nor do we always agree, but right is right and wrong is wrong. Mrs. Forrest told Mr. Moore he will receive all the information he needs. Anyone elected to the board in the future, should contact the board office to see what they need to do. If you heard Ms. Leary tonight, she stated she was putting together hard copies of "new board member packets". She said if you have a question, shut up and listen. She has been a board member for 10 years and works harder as a board member, than on her own job. She doesn't get paid and nothing is being hidden. Ms. Wright told Mrs. Forrest not to explain anymore. Mr. M. Mears asked if the board would be follow--ng "Robert Rules". Mrs. Forrest asked if there was anything for Executive Session. Mr. Rhone asked to clarify things. He said as part of "Robert Rules", things can be walked on to the agenda however; the power lies with the president to add the item. Generally, you ask the board president and it is usually done for emergent matters or items that have arisen out of questions that came up during the meetings such as motion to resend something or amend something.
