Discussion Items:

Outreach – none

Roofing Update – was provided by Dr. Johnson. The project will be finished soon. Inspector has signed off and custodians have cleaned the rooms. Damages were done to the sidewalk. Repairs will be done. There were 6-7 additional concrete slabs that need to be repaired.

Cares Update – Dr. Johnson explained the use for the additional CARES ACT money. There are two options for sanitizing the classrooms: individual portable units and retro fitted components for the current systems.

Bussing Contract – Ms. Leary explained the bid received for transportation as well as the per diem cost and aide.

Sidebar Agreement – Dr. Johnson explained the 50% funding for staff members as well as the remaining balance to be filled once the authorization agreement is signed. The new Educator Health Plan (EHP) was also discussed and will take place on January 1, 2021.

Open Positions – Dr. Johnson discussed the open positions, Financial Literacy (math enrichment), Media Specialist, World Language (may replace Spanish) and substitute custodians.
