New Business

Highlights of the proposed budget were reviewed. State aid numbers were released earlier today; the district realized a slight increase because of "Choice Aid". Salaries have been increased slightly; these are estimated amounts as no guides are in place for 2013-2014 because the LEA contract expires as of June 30, 2013. Again this year projected tuition obligations have deceased. Two high school placements will age out, several out-of-district students have moved, and there is a prior year tuition credit from Haddon Heights. Following the suggestion of the district's auditor, several "one time" purchases are incorporated into the budget; such as classroom furniture, computers, computer furniture and a new K-6 reading/language series. There was a brief discussion regarding the position of Librarian. The tax levy needed to support the proposed budget is slightly less than that of the current year's.
