As I'm sure you are aware, we successfully completed the March section of the PARCC and were one of the lucky districts that had no issues with the initial testing: we had no students opt out of the test, there were no glitches with the technology and because of the amazing scheduling, our students missed minimal instruction time!

This was a whole group effort, from the Board, Dr. Johnson, the administrative team members, to the Lawnside staff and the parents. I know you have heard the adage that "it takes a village", well our village is working together to do what's right for our students and it certainly was evident when our  $3^{cl} - 8^{th}$  graders took the PARCC in March. On behalf of the LEA I want to thank the Board and administration for all of your support and accommodations throughout the school year.

And that's what brings me to speak to you tonight.

There has been a lot of coverage about the PARCC test and we still don't know what the legislature will do about PARCC. However, I am asking you to stay informed about PARCC to make sure our students are not over tested or improperly labeled by test results. The members of the Lawnside Education Association hope that we can continue to work with the Board and Administration to ensure that our students receive the best education possible. Thank you.
