## Lawnside Board of Education Meeting Minutes May 7, 2015

A Special Meeting of the Lawnside Board of Education was called to order at 7:03 p.m. in Board Conference Room of the Lawnside Public School, 426 Charleston Avenue. Board President Sabrina Forrest presided. After repeating the Pledge of Allegiance and observing a moment of silence, the following members answered present to the roll call:

### **Public Comments**

Mayor Mary Ann Wardlow expressed thanks on behalf of the family of Councilperson Lucille Wakefield-Moore. The family was overwhelmed by the outpouring of condolences and support they have received.

Mayor Wardlow further conveyed the uniqueness of the relationship between the Superintendent, School Board President and herself. In other municipalities, these titled individuals often are at odds and do not get along nor work in collaboration. She briefly outlined the proposed summer program to be run by the YMCA. A fee will be charged; children can participate on a full-day or half-day basis; flyers are forthcoming.

Board Member Rhonda Wardlow-Hurley entered at 7:05 p.m., making 7 present, 1 absent.

Public Hearing on 2015-2016 Budget

The Superintendent presented a PowerPoint slideshow to report the district goals and school highlights for the current school year as well as outline the proposed enhancements contained in the 2015-2016 budget. The proposed enhancements were categorized as follows: Academic and Instructional Improvements, Technological Upgrades, Facility Renovations Enhancements, and Community Outreach Initiatives. The Board Secretary presented a slideshow to review all areas of the proposed spending plan for 2015-2016; the presentation included a comparison of the current year with that of the ensuing year.

The 2015-2016 budget that was approved by the Executive County Superintendent totaled \$8,858,621 and was categorized as follows:

The breakdown of the proposed Operating Budget for the 2015-2016 school year is as follows:

Aid received was the same as the 2014-2015 school year. The tax levy needed to support the Operating Budget for the 2015-2016 school year is 4,177,499; this is 114,417 more than the current school year and represents a 2.82% increase. The projected tax rate is 2.024 per 100 assessment, a 7.54 increase.
