On the motion of Mr. Durio, seconded by Mr. Clay, and carried, the Board approved the following Finance Committee recommendations:

- a) Accept the following group health plan changes: (OPPOSED: Mr. Potier)
 - 1) All GLP-1 prescriptions must be filled through RX Compass effective 10/1/24 members currently on these medications will be receiving correspondence from Liviniti on this change
 - 2) Changes to deductibles, maximum out of pocket expenses, and copays effective 01/01/25
- b) Transferring \$750,000 from the general fund to the group health fund to offset the past 3 years of deficit spending in the group health plan effective immediately (OPPOSED: Mr. Potier)
- c) Proposed Group Health Rates, as follows:
 - 1) Increasing group health premiums by 10% for both the employee/retiree share and the board share effective 01/01/25
 - 2) Renewal of UHC rate of \$345 per retiree effective 01/01/25
- d) Loan SMSH and SMJH Band \$42,000 for band equipment
- e) Loan BBHS Track \$58,000 for equipment
- f) E-Rate Request for Proposals Category 2 Products and Services
- g) Residents' Incentive Program
