








Demographic Projections 2023-2024 Henry C. Beck Middle School








Demographic Projections 2024-2025 Henry C. Beck Middle School














Demographic Data 2022-2023 John A. Carusi Middle School
















Demographic Data 2022-2023 Rosa International Middle School












Economically Disadvantaged


• Students who are eligible for free or reduced meals based on meal applications submitted.

Free & Reduced Lunch Eligibility – as defined by the National School Lunch Program

- Children in households with incomes below 130 percent of the Federal poverty level or those receiving SNAP (Supplemental Nutrition Assistance Program) or TANF (Temporary Assistance for Needy Families) are eligible for free meals.
- Those with family incomes between 130 and 185 percent of the Federal poverty level are eligible for reduced-price meals.


Economically Disadvantaged Projections 2023-2024





Economically Disadvantaged Projections 2024-2025




