What We Know

- 5 years to implement
- Must service 90% of universe
- Maximum class size is 15
- 2:15 Teacher/ Student ratio
- All special education programs will be full day
- 6 hour instructional day
- Must use an approved State curriculum
- Application due in August, Notification in September

What Will Be Taught (tentative) Cherry Hill Public schools



Arrival, preparation, and choice activities	30 minutes
Group Meeting	20 minutes
Choice Time	60 minutes
Cleanup, handwashing, and snack	20 minutes
Small Groups	20 minutes
Outdoor Choice Time	40 minutes
Read-Aloud	15 minutes
Lunch	40 minutes
Rest/Quiet Activities	45 minutes
Outdoor Choice Time	30 minutes
Read Aloud	15 minutes
Limited Choice Time and Small Groups	30 minutes
Group Meeting and dismissal	20 minutes





Transportation



- Bus routes need to be finalized (contingent upon location of students) before routes can be put out to bid
- Anticipated July bid dates for busing
- Starting and end time of program may impact availability of buses
- Contractors need appropriate buses to transport preschool students
- Car seats
- Routes will have aide to assist with loading and unloading students

- The dedication, commitment, and advocacy for students with Individualized education plans will be unwavering
- The times for the 2023-2024 academic day have not been determined
- There will be a Preschool Committee (when appropriate)
 - Teachers, administrators, community members, experts from the field



In the Know



- There will be no aftercare programs (SACC) offered at Malberg
- Transportation will be provided for eligible students based on District policy for grades K-12 (revisions in process)
- We will be applying for the Preschool Expansion Grant when it becomes available
- We will continue participating in NJPSA/FEA's Transforming Early Childhood Leadership Institute in partnership with the NJ DOE Early Childhood Services Division
