New Business

Update on School Planning for August 26, 2020

Superintendent Whitmoyer updated the Board on the planning for the upcoming school year. The plan is to open the schools for all students and also provide distance and remote learning for those families that choose the remote learning options. This plan will be in place until the governor moves the state to Phase 3.

Motion by Trustee Scheet, seconded by Trustee Bokovoy to approve the administrative plan to open the schools for the 2020-2021 school year in a block schedule plan. Unanimous vote for the motion.

Summer School Program Update

Principal Rispens discussed the planning for the upcoming summer school program. Since the current School Board motion to use remote learning until June 10th will expire on the last day of school, the return to standard operations in the school will allow summer school to proceed. Of course the district will remain committed to provide the safest possible education situation for students and staff by using the CDC and County Health Department recommendations to operate this limited program bringing the children back into school to attend the summer school program. Principal Rispens also reported that for the first time the district will be offering a distance learning program for students who do not want to come into the classrooms. The district was able to hire an instructional tutor to help 6 high school students who will be working with the Montana Digital Academy.

Motion by Trustee Bokovoy, seconded by Trustee Diehl to approve the summer school program as presented, Unanimous vote for the motion.

Title I Program Review Parent meeting

Superintendent Whitmoyer reviewed the Title I Program for K-12 for the upcoming school year. Meeting minutes are included with these minutes.
