Principal's Report Agenda Item 5.1

On October 12th, we had our annual Celebration of Partnerships. At this meeting, we had over 150 in person advisory members that met with each of our programs and many more on site through virtual means. At this meeting, our instructors discuss what is going on at Tech Campus, with our students and where the program will be headed. We focus on three facets of an advisory committee; Advise, Assist and Advocate. These three facets are paramount in helping our partners learn how they can help Tech Campus and our students. Principal Burress explained each of these facets through an all school virtual presentation that showcased some of our partners and how they advise Tech Campus, Assist Tech Campus and advocate for Tech Campus and our students. The meeting was well received and we look forward to continuing it into the future.

On October 26th, Tech Campus held its first Counselor, Special Education and

Support Staff Meeting of the school year. We hosted this meeting both in-person and virtually for our member district's convenience. The meeting focused on special education data, our standards based grading program, marketing of Tech Campus and the rollout of the new College and Career Endorsement for our students. We hope that your teams found the information relevant and useful.

Tech Campus will hold its annual open house on November 3rd. The Tour of Tech is always well received and we are excited for the programmatic projects going on in each of our areas. This is a great opportunity for not only current parents and students to see our school, but also prospective students to get a chance to discover CTE. We had well over 1,000 attendees at this event.

Associate Principal Report

Agenda Item 5.2

Future Quest was held October 18, 19, and 20. We received a lot of positive feedback from students, parents, and school chaperones. Approximately 800 students from 15 different middle schools attended.

All middle schools have received a copy of the Lake County Area Vocational Career Guide to assist in guiding conversations with parent, counselors and students on narrowing down likes and dislikes as they enter high school. This magazine highlights options locally in Lake and the surrounding counties.

All elementary schools in Lake County that have kindergarten classrooms received a set of career figures, career puppets, and Community Helper books. A curriculum was also sent with these materials to highlight how to utilize these within existing curriculum (STEM, ELA, and MATH).

Grants are in full swing and we are beginning reimbursements of Perkins activities. We have received \$800,000 in CTEI funds and are beginning reimbursements of that grant as well. Schools should be reviewing their grant approved programs of study as LCAVS begins the process of assisting districts in creating at least one approved Career Pathway Endorsement.
