Minutes of Regular Meeting

March 16, 2021

Board Members Present: Chairperson- Ogleretta White, Vice Chairperson-Patricia Atkinson, Levant Davis, Mrs. Susan Pridgen, Mrs. Foxworth and Mrs. Linda Neal.

Board Members Virtual: Rev. Cynthia V. Brown (Zoom).

Call to Order & Notification of Board Workshop: The Board meeting was called to order at 6:06 p.m. by Chairperson-White. In accordance with the S.C. Code of Laws, 1976, Section 30-4-80 (d) as amended, the local media was notified of the time, date and place of the meeting. Mrs. Hopper stated that the media was notified of the meeting and a copy of the agenda was also provided.

Invocation: A Moment of Silence.

Welcome to Staff and Visitors Present: Chairperson-White welcomed the staff to the March 16, 2021 meeting.

Establishment of Quorum: Chairperson-White verified that a quorum was present.

Approval of Agenda: Chairperson White asked for approval of the agenda. Mr. Davis moved, seconded by Mrs. Pridgen to approve the March 16, 2021 agenda; and the vote was unanimous. (Mrs. Foxworth, Mrs. Pridgen, Rev. Brown, Vice-Chairperson-Atkinson, Chairperson-White, Mrs. Neal and Mr. Davis).

Approval of Minutes: Chairperson White asked that the minutes the Regular Meeting of February 16, 2021, Policy Workshop minutes, February 23, 2021 and minutes of the Budget Workshop March 2, 2021 be approved. Mrs. Foxworth moved, seconded by Mr. Davis to approve these minutes; and the vote was unanimous. (Vice Chairperson-Atkinson, Mrs. Neal, Mr. Davis, Mrs. Pridgen, Rev. Brown, Chairperson-White and Mrs. Foxworth).

SCSBA Board Recognition: Dr. Bethea, along with Chairperson-White presented certificates from the SCSBA recognizing Mrs. Nadine Foxworth and Mrs. Pridgen for completing New Board Member Orientation. Rev. Brown was presented a plaque and pin for reaching Level 6 (Highest Level) for the South Carolina School Board Association.

Reports from Administration / Review and Action Items:

Curriculum and Instruction Report/Updates 2021-2022 Calendar: Ms. Melonie Gordon presented the calendar for the 2021-2022 school year for the Board's approval. It had previously been voted on and chosen by the Marion School District. Ms. Gordon made the Board aware that there maybe some changes pertaining to the Covid-19 pandemic and weather conditions. After a brief discussion, Chairperson White asked for a motion to approve the 2021-2022 calendar for the upcoming school year. Motion by Mr. Davis, seconded by Rev. Brown; and the Board voted unanimously to approve this request with the knowledge that it may be revised later. (Rev. Brown, Chairperson-White, Vice Chairperson- Atkinson, Mrs. Foxworth, Mrs. Neal, Mrs. Pridgen and Mr. Davis). The Board thanked Ms. Gordon for her report.

Finance Report December 2020: Mr. Lane presented the Finance Report for the month of February. After Mr. Lane's presentation, the Board thanked him for the report.

Facilities/Operations Report: Mr. Sturkey presented the Operation's report for the month. He also briefly discussed the Fox Field and minor repairs that may be done by the District.

Contractual Services for 2021-2022 School Year (RFP): Mr. Sturkey stated that he would need Board approval for the RFP for the Lawn maintenance, pest control and custodial supplies for 2021-2022. Human Resources Report / Updates – Mrs. Paula Grant presented the personnel actions for Board approval. Chairperson White asked for a motion to approve the personnel actions. After a brief discussion in reference to resignations during the middle of the school year, motion was made by Mrs. Neal, seconded by Mrs. Foxworth to approve the personnel actions as recommended by the Superintendent; and the Board voted unanimously to approve this request. (Rev. Brown, Chairperson-White, Vice Chairperson- Atkinson, Mrs. Foxworth, Mrs. Neal, Mrs. Pridgen and Mr. Davis). The Board thanked Mrs. Grant for her report.

Chairperson White reminded members of the upcoming meetings and events. She stated that immediately after the Strategic Planning Workshop on March 30th @ 6:00 pm, the Board would begin the process of debriefing some of the selected policies and will continue during Phase II of the Budget Workshop on April 13, 2021 @ 6:00 pm.

After a brief discussion, the Board agreed not to attend this year, but look into the cost of being a member.

Facilities Study

The district is in the beginning stage of a facilities study. The RFQ was issued on February 26, 2021. Bids will be opened on March 15th at 10:00 am.

The South Carolina Department of Education Office of School Facilities, has given approval for the district to replace the Mullins High School fire alarm panel. The bid was published on March 4, 2021, and will be received until April 1, 2021 at 9:30 am.

General Administrative Reminders/Updates from the Office of Superintendent:

5 Day Face-to-Face: Week 1

Our primary and elementary school faculty, staff and students did a phenomenal job this week! It was nice visiting schools seeing our students safely interacting with peers! We can't wait for the full return of our middle and high school students!

Board One-on-One Sessions:

Individual sessions with Board members have started and I wish to thank each of you for taking time to engage in a dialogue with me, as we collaborate and share ideas, challenges, and bright spots with a goal of making decisions that will benefit our students.

Marion County Sale of Blumenthal:

A special "Thank You" to Marion County Administration for presenting the district with an unexpected check that was made possible due to the sale of Blumenthal Mills (for ½ of taxes generated - \$201,901.24).

Upcoming Student Outreach Initiatives:

In an effort to reconnect with students that have withdrawn during the pandemic, the district will be sending a postcard to each student who still lives in the County. The postcards will have a special message from me, letting the students know that we miss them and we look forward to having them back in our schools soon!

We are also having Door Hangers made to personally connect with students that are having attendance or truancy issues. The goal will be for a school official to visit the homes of students that are on the path to truancy. The door hanger will be a friendly reminder that they need to reconnect with schools.

Both of these projects will be in effect after Spring Break!

Human Resources:

February was an exciting month as we continued to host our weekly virtual recruitment fairs and also attended virtual fairs hosted by colleges and universities. These activities will continue throughout March as well. We have met with all Principals to begin the personnel needs assessment for staffing for 2021-2022 and the Teacher of the Year selection process is underway.

Student Services:

The district's Multi-Tiered Systems of Support (MTSS) team, composed of 20 district administrators, principals, lead teachers and counselors meets monthly to create a system of support in all MCSD schools as it relates to attendance, social-emotional learning, behavior and academics. The State Department of Education, as well as the Behavioral Alliance of South Carolina, provides external support to the leadership efforts of our district's MTSS team. A vision has been developed and the team's focus is on strengthening MTSS leadership at the district and school level.

Technology:

Technology is working on a plan for the collection of the student devices as well as a plan to reimage and repair those devices. We are also continuing to respond to helpdesk calls and emails though we are not manning the desk at this time due to a tremendous drop in call volume. Calls are now going straight to voicemail after 8:30 and are being returned by a technician.

Federal Programs:

- We are in preparation for a Title III Monitoring Visit and are conducting an internal personnel audit of positions.
- RBHS (Medicaid Program) is being restructured.
- We are brainstorming ways to address SPED student academic loss.
- The finance departments (Title I, Title III, Title IV, Title V, and IDEA) of Federal Programs are preparing to closeout funding that ends June 30, 2021.

Teaching & Learning:

- Sixty percent of the 235 survey respondents would like their children to attend Virtual Academy in the 2021-2022.
- Planning for Spring Testing.
- Continuing the Strategic Planning process.
- Planning summer PD for teachers, planning summer programs for students (enrichment and intervention)
- Pacing and planning sessions have now been held for all "tested areas" core subjects.
- Spring writing prompts were administered to all students in grades Kindergarten - English 2. Teachers are in the process of scoring the writing prompts and planning next steps.
- Read Across America Week was celebrated March 1 - 5, 2021. Each day schools participated in planned activities and a guest reader read a Dr. Seuss book.
