### **Application for Appointment as Trustee, Single-Member District 1, To Fill Unexpired Term Until May 2025 Election**

Thank you for your interest in applying for appointment to the Greenville ISD Board of Trustees.

The Greenville ISD Board of Trustees plans to fill the Single-Member District 1 vacancy by **December 1, 2024**. To be eligible for the position, you must be a resident of Greenville ISD Single-Member District 1. The individual appointed will serve until the May 2025 election, at which point the position will be placed on the May 2025 ballot. The individual appointed by the Board has the choice whether or not to file for a place on the May 2025 ballot. However, it is the Board of Trustees' preference that any individual seeking appointment also intends to file for a place on the May 2025 ballot for Single-Member District 1. The Application for Appointment is enclosed. Please ensure you have responded to all questions prior to submitting the application.

**Application Deadline:** Monday, November 11, 2024, at 4:30p.m. Applications must be received by the Superintendent's Office on or before the deadline.

I am aware that knowingly providing false information on the application regarding my possible felony conviction status constitutes a Class B misdemeanor. I am a registered and qualified voter in Hunt County, Texas and have resided continuously in Texas for 12 months and in Trustee District 1 of the Greenville Independent School District for at least the six (6) months immediately preceding the date of this Application. I further swear that the foregoing statements included in my application are in all things true and correct.”
