-All Wisconsin public and private 4k-12 school experience in a 50% or more regular/permanent position is considered as a part of step placement. This does not include substitute teaching, long-term substitute teaching, student teaching, practicum teaching etc.
-All out-of-state (not Wisconsin) 4k-12 school experience in a 50% or more regular/permanent position is considered as a part of step placement. This does not include substitute teaching, long-term substitute teaching, student teaching, practicum teaching etc.
-All international 4k-12 experience if a license was required, if in a 5% or more regular/permanent position is considered as a part of step placement. This does not include substitute teaching, long-term substitute teaching, student teaching, practicum teaching etc.
