### 6.1 Annual Financial Report FY2024

What is our classroom spending 24-25?

FY2025 only has three (3) months of expenditures, and it is too early to analyze spending at this time.

Are we continuing to decline or are we going to make an effort to put more money into the classroom? Can you please explain the decline in classroom and instructional support spending?

The main reason for the decline in classroom spending in FY24 was in FY23 the district expended \$2.7million for the science curriculum.

Breakdown the dollars in the classroom trend by category. Teacher headcount up and salaries up but dollars to the classroom going down. Why?

Due to FY23 \$2.7million dollar science curriculum.

What is our FY 2023 Instructional spending percentage? FY23 was 60.1%

Why is administration spending going up when headcount has been the same the last 2 years?

Part of the increase is from the Governing Board approved raises for all Employees for FY24. In addition, the district had several long-time administrators leave or retire from the district and the district had higher than normal payout of vacation and general leave.

Pg 10 of presentation - Please explain budget balance decreasing. Please provide specific numbers.

The specific numbers of the budget balance decrease are on Page 6 and Page 7 of the presentation.

Pg 10 of presentation – Do you have a sample of the policy, and can you explain why you are proposing such policy?

Financial Services will present a draft policy language at a future board meeting. Looking at the End Budget Balance Policy to adopt-in future budgets can we isolate the budget balance carryforward, so we don't have for example 60 mil in instruction when we are only going to spend forty?

This can be taken into consideration.

Can we also have a conversation about a cash fund policy? For example:

- -Every budget cycle the cash accounts are brought to the board for discussion so the board is aware.
- -If at any point these cash funds are anticipated to grow from what they were a year ago, it warrants a board conversation because some of these funds can be

### used.

Cash funds will be included in the draft budget balance carryforward policy language.



Timeline for Classified Staff:



How are administrators and teachers being encouraged to actively participate in the process and share evidence of their practice?

During the formal observation process (pre/post observation meetings), teachers and administrators have the opportunity to share their thoughts on the lesson that was observed.

What mechanisms are in place to ensure that the feedback from evaluations is constructive and contributes to instructional improvement?

Administrators must complete Qualified Evaluator training, provided by the district, prior to being approved by the board as a Qualified Evaluator.

How will teachers be evaluated and provided with ratings for each component after formal observations, and how will this support their professional growth? All walkthroughs and formal observations are based on the Danielson Framework components. Any area of growth identified is discussed in the meetings between teachers and administrators. Final ratings are provided and discussed during the Summative Evaluation at the end of the year.

What measures are being taken to ensure that the framework aligns with the district's educational priorities and goals?

The framework is structured to include domains present in the work teachers perform each day: planning and preparation; classroom environment, instruction, and professional responsibilities. These domains are reflected in all four Strategic Anchors.

What indicators will be used to measure the impact of the framework on teaching practices and student outcomes?

The Danielson Framework and the teacher evaluation process are components within Strategic Anchor 1, 2, 3, and 4. Indicators, such as 1.1, 1.2, 1.4, 1.5, 2.1, 2.3, 3.1, and 4.3 can all be supported through the Danielson Framework.
