# What is Title I?



Title I began in 1965 (ESEA) as a federal program to ensure equal opportunities for low income school districts.

Through Title I, the federal government disburses money to school districts based on the number of low-income families in each district as determined by census data.

The school uses its Title I money to supplement and improve educational programs offered to help ALL students meet state standards.

### The Purpose of Title I

To ensure that ALL students have a fair, equal, and significant opportunity to obtain a high-quality education and reach, at a minimum, proficiency on challenging State academic achievement standards and State academic assessments.

### Title I Money

These funds may be used for children from preschool aged to high school. Title I is designed to support State and local school reform efforts tied to challenging State academic standards in order to reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement.

### How our School Spends Title I Money

- Hiring additional teachers and other support staff
- Providing professional development for teachers and staff.
- Purchasing supplemental (additional) instructional materials, resources, and educational programs.

Staff Members provided by Title I help to lower the student-teacher ratio.


