What is Title I?

What is it?

- 1. There will be an increase of 5% potential growth of students scoring at the Proficient and Distinguished Level on the Georgia Milestones in ELA.
- 2. There will be an increase of 5% potential growth of students scoring at the Proficient and Distinguished Level on the Georgia Milestones in Mathematics.
- 3. To improve the overall safety and climate of our school for all students and staff.
- 4. Grow the overall professional capacity and efficacy of our staff.
