Shall the School Budget as proposed by the Board of Education for the school year 2024-2025 in the amount of \$45,315,278 be adopted and the necessary taxes be levied thereon?		Shall the Board of Education of the Elmsford Union Free School District be authorized to expend a sum up to \$9,586,251.00 from (a) the remaining balance of the funds held in the Capital Reserve Fund established through the District's Annual Meeting and Election held on May 17, 2016, which balance as of 8/30/2023 was \$83,090.00, plus any interest earned on such balance until fully expended, and (b) a sum not to exceed \$9,500,000 from the Capital Reserve Fund established through the District's Annual Meeting and Election held on May 15, 2018, in order to (1) replace the heating, ventilation and air conditioning systems and building management system of the Alice E. Grady Elementary School ("Grady ES"), including any necessary equipment, machinery, apparatus, demolition, related electrical work and as needed related abatement of materials; (2) replace the roofing systems of Grady ES and Dixson Primary School, including as needed installation of insulation, related exterior masonry work, connection of downspouts, and necessary abatement of materials; (3) replace classroom unit ventilators at Grady ES; (4) repair and repave the parking lot of Alexander Hamilton High School ("AHHS"); (5) install Districtwide security cameras; (6) replace Districtwide phone system with Voice Over Internet Protocol ("VOIP") phone system; and (7) replace public address system in AHHS and Grady ES and to pay for the related associated costs of each of these projects, including the costs of professional services (architect, engineers, testing and commissioning) for each of these projects.

RESOLVED, that the Board of Education of Elmsford Union Free School District is hereby authorized to establish a Capital Reserve Fund to be known as the "Elmsford UFSD Capital Reserve 2024" in the ultimate amount of Five Million and no/100 (\$5,000,000.00) Dollars plus interest earnings thereon having a probable term of ten years, for paying the cost of improving, repairing, reconstructing, renovating, building new, and constructing additions to School District buildings, facilities, property, and athletic fields, courts and facilities, including but not limited repairing, replacing, adding or upgrading infrastructure, electrical systems, roofs, windows, gutters, interior or exterior doors, masonry, building systems (e.g. fire alarms, PA sound systems, building management systems, air handling systems, moisture deterrents, backflow preventers), boilers, heating systems, ventilation systems, air conditioning systems, plumbing systems, stormwater mitigation, detention and retention (e.g., piping, culverts, retention basins, catch basins), kitchens, cafeterias, libraries, offices, classrooms, restrooms, health, safety and security measures (e.g. security cameras, vestibules, electronic access, locks), site work, drainage and irrigation systems, bleachers, parking lots, stairs, sidewalks, pathways, fencing, electronic locks, interior and exterior lighting, press box, concession stands, and/or other needs identified in the School District's current Five-Year Building Conditions Survey or identified in a future Five-Year Building Conditions Survey undertaken during the term of this capital reserve fund, and/or the costs of acquiring outdoor mechanized maintenance equipment, which capital reserve fund shall be funded through budgetary appropriations, appropriations of unassigned fund balance, transfers when warranted and properly authorized from other reserve funds, revenues not required by law to be paid into any other fund or account.		RESOLVED, that the Board of Education of the Elmsford Union Free School District is hereby authorized to deposit in the Repair Reserve Fund in an amount not to exceed One Million, Five Hundred Thousand and no/100 (\$1,500,000.00) from the 2023-2024 unassigned fund balance for repairs of capital improvements or equipment, which repairs are a type not recurring annually or at shorter intervals.
