Davis, Mr. Cox-Bey, and Mr. Fickes were all thanked for their work to ensure this trip happened by Board Members and Dr. Cunningham.

Mr. Brown moved, Mrs. Moody seconded the **Approval of La Rabida Children's Hospital Agreement** as presented by Mr. Fickes. This is a program to educate students on sexual abuse, prevention, and health programming. This was previously approved, however, there were some minor changes made to the agreement that required this to be approved again. APPROVAL OF LA RABIDA CHILDREN'S HOSPITAL AGREEMENT

Mrs. Moody moved, Mr. Banks seconded the Approval of the resolution for the issue of not to exceed \$35,000,000 General Obligation Limited Tax School Bonds of the District for the purpose of increasing the Working Cash Fund of the District as presented by Mr. Horton. This resolution sets forth the parameters for the issuance of said bonds and sale thereof by designated officials of the District and summarized the pertinent terms of said parameters, including the specific parameters governing the manner of sale, length of maturity, rates of interest, purchase price and tax levy for said bonds. On roll call, Members Moody, Banks, Brown, Davis, Graham, and Lawrence voted aye; voted nay, none; motion passed.

APPROVAL OF THE RESOLUTION OF WORKING CASH FUND BONDS

Mrs. Moody moved, Dr. Davis seconded the Approval of the Resolution authorizing the appointment of Township Trustee of Schools as presented by Mr. Horton. This is to approve an appointment of Dr. Nathaniel Cunningham, Jr. to serve a two-year term, which may be renewed, as the District's trustee of schools for Thornton Township. On roll call, Members Moody, Davis, Banks, Brown, Graham, and Lawrence voted aye; voted nay, none; motion passed.

APPROVAL OF THE RESOLUTION AUTHORIZING APPOINTMENT OF TOWNSHIP TRUSTEE OF SCHOOLS

Mrs. Lawrence moved, Mr. Banks seconded the Approval of the Press Plus Policy Update for Issues 114 & 115 as presented by Dr. Doss. The Policy Committee reviewed the draft updates and review and monitoring policies. They were available for review at our district office. Dr. Cunningham stated the following: Good evening:

SUPERINTENDENT REPORT

Today, we commemorate Patriot Day, a solemn day of remembrance for the lives lost during the terrorist attacks on September 11, 2001. On that fateful day, our nation witnessed unimaginable tragedy at the World Trade Center in New York City, the Pentagon in Virginia, and on United Airlines Flight 93 in Pennsylvania. We honor the 343 New York firefighters, 55 military personnel, and 23 New York City police officers who made the ultimate sacrifice while trying to save others at the Twin Towers and the pentagon. Their bravery and selflessness are etched into our collective memory, much like the days our parents remember losing JFK, Dr. King, or RFK. Just as they recall where they were during those moments, we too remember where we were on 9/11.

I vividly recall being in the high school library when someone turned on the television. Together, we watched in horror as the second plane hit the tower. We witnessed firefighters and police officers desperately working to save as many lives as possible. We saw the choking smoke and dust envelop the city as the towers fell. Amidst the chaos, we also saw lives being saved because of the courageous service of others.

While we may not be military personnel, police officers, or firefighters who face danger daily, we too serve our community in meaningful ways. I want to extend my heartfelt gratitude to every educator who comes to school daily to serve our children and communities. Service takes many forms—teachers, CEOs of nonprofits, DCFS workers, mail carriers, doctors, and here at District 205, our dedicated Board of Education members—who served or are serving in the previously mentioned roles.

On this Patriot Day, we honor those who serve in all capacities, especially those who serve our community. Thank you for your unwavering commitment to our students and our community.
