Dr. Cunningham stated the following:

Every year that I have been in the district, we have been Teaming together to move us forward. Although the expectations have been the same, the evaluation system has changed. The district office completed a book study three years ago on the Four Disciplines of Execution by McChesney, Covey, and Huling. The Four Disciplines are a simple, common-sense approach that leaders and teams use to ensure they accomplish their priorities. The Four Disciplines are as follows: (1) Focus on the wildly important, (2) Act on the lead measures, (3) Keep a compelling scoreboard, and (4) Create a cadence of accountability. We used this researched based book to develop what we call the Daily Disciplines of Execution. It is based on two things: the Silver Strong Administrative Evaluation system and the 4 Disciplines of Execution. Last year was the first year of the new administrative evaluation system.

The practice of the new system is that we follow the requirements of Illinois law, including the preconference, informal observation, and observations. The practice includes monthly observations by the Superintendent, the Associate Superintendent, the Assistant Superintendent and the Principals.
