SUPERINTENDENT REPORT

Dr. Cunningham stated, the passing of SB 100, the rules that remade school exclusionary discipline, was a watershed event for our district. Exclusionary discipline describes any school disciplinary action that removes or excludes a student from his or her usual educational setting.

- Most common exclusionary discipline practices at schools include suspension and expulsion.
- To improve processes and support students, instead of excluding them, the district created two district programs and new processes for internal exclusion.
  - o Internal (in-school suspension), suspension 1-10 days
  - o Expulsion, more than 10 days
- The district reduced all exclusions and specifically changed how internal exclusion is completed. Changes were made to ensure that students were not severely impacted by exclusionary discipline.
- The district's internal exclusion plan changed significantly. Previous plan had students serving full days of in-school suspension. Current system based on needs of students. Issues that requires internal exclusion:
  - Student placed in a restorative justice program designed to support needs while keeping out of class as little as possible.
  - Designed to teach students, not to punish them. This system will improve our school's internal culture, student behavior and student academic skills.

The district's suspension system was split into two parts by law.

- 1st part Exclusions from one to three days. According to ILCS 5/10-22.6 b-15, Out-of-school suspensions of 3 days or less may be used only if the student's continuing presence in school would pose a threat to school safety or a disruption to other students' learning opportunities. This can be used for fights, threats, bullying, etc.,. It is important that it is noted that each incident is individual and is looked upon on its own.
- 2<sup>nd</sup> part Exclusions of greater than three days but less than eleven days. ILCS 5/10-22.6 b-20 states, "out-of-school suspensions of longer than 3 days may be used only if other appropriate and available behavioral and disciplinary interventions have been exhausted and student's presence in school would either (i) pose a threat to the safety of other students, staff or members of school community or (ii) substantially disrupt, impede or interfere with the operation of the school.
- Final process of exclusionary discipline is expulsion. Expulsion in the state of Illinois is any exclusionary discipline that is longer than 10 days and shorter than two years and only available in the state of Illinois up to two years. ILCS 5/10-22.6 b-20 states, "expulsions, and disciplinary removals to alternative schools may be used only if other appropriate and available behavioral and disciplinary interventions have been exhausted and student's presence in school would either (i) pose a threat to safety of other students, staff or members of school community or (ii) substantially disrupt, impede or interfere with operation of school. In our district, we have developed a process to avoid expulsion if at all possible (Expulsion is required if a gun is brought to school).

District 205 has two district programs designed to offer students the opportunity to remediate their behavior or credits.

- Peace Program is a therapeutic program that works to help students deal with behavior issues and allows focus on their academics as they improve social and behavior skills.
- Outlook Academy (OA) is for juniors and above who are significantly behind in credits.
  Also accepts students who have dropped out of school. There are students that would
  not be able to graduate without the intervention of OA. Both programs, Peace Center
  and OA, offer our students an opportunity to get back on track for graduation. Since
  their inception, they have allowed students that have made mistakes an opportunity to
  receive high school diploma.

As for exclusion, we continue to use where necessary, while working on programs that alleviate the practice. One such program:

 Restorative Justice Program. Dr. Shaniqua Jones and her team are working to train staff members, intervene inappropriate student behavior and teach students how to deal with difficult situations in a positive manner. This program again focuses on teaching students not punishing them. In order to do better, we have to know better. The Restorative Justice program is teaching our students.

Final note, each building reduced the number of exclusionary discipline issues last year while the district had no expulsions. We will continue to work on reducing exclusionary discipline to ensure our students are enrolled, enlisted or employed upon graduation.
